Re: LA-R-89 and Consent Election Agreement

Gentlemen:

Pursuant to a letter dated December 15, 1976 from Mr. Spicer informing us that a number of teachers would not be involved in "Professional Growth Day" and thus entirely free to vote as would the large majority of teachers, I arranged for Mr. Jeff Paule, our attorney on the staff, to meet with representatives of all the parties on January 5, 1977 to try to work out an acceptable accommodation. Mr. Paule reported that it was not possible to get an agreement from all parties, but that the District's representative assured him that arrangements will be made to allow those employees who are teaching on February 4 to vote at the nearest polling site.

Therefore, I have decided that we will proceed with the election as set forth in the Agreement signed by each of you on December 8, 1976.

In response to the letter from Frances M. Slowiczek dated December 27, 1976 concerning releasing teachers for a period of time prior to the election, I refer you to Section 3543.1 of the Rodda Act which does not require the employer to provide release time for the purpose of organization campaigns and elections. I, therefore, decline to "overturn the decision of the San Diego Superintendent".
