# STIPULATION CAR / 2 / 2

It is hereby stipulated by and between Gary Robinson, for and on behalf of the California Federation of the Union of American Physicians and Dentists (UAPD) and David L. Suddendorf, for and on behalf of the Public Practice Bureau and California Medical Association as follows:

The Public Practice Bureau agrees to submit to the California Public Employment Relations Board (PERB) a request to amend its original intervention petition which it filed in connection with its attempt to become the exclusive representative of Unit 16 employees under the State Employer-Employee Relations Act (SEERA). This request to amend shall request that the name of the organization appearing on the ballot shall be "Public Practice Bureau". The phrase "of the California Medical Association" appearing immediately after "Public Parctice Bureau" on the original intervention petition shall be deleted from the name of the organization as it appears on the official Unit 16 representation ballot. Concurrent with this request to amend, the UAPD agrees to withdraw its challenge to the employee organization status of the Public Practice Bureau and/or the California Medical Association now pending before the PERB as Case No. S-SR-16.

It is agreed by the parties that the Public Practice Bureau's deletion of the phrase "of the California Medical Association" from the official SEERA Unit 16 representation election ballot in no way affects the Public Practice Bureau use of the

name "California Medical Association" in its correspondence, campaign literature, newsletters or in any other manner it might choose. Both parties join in asking the PERB to permit amendment of the intervention petition and the official ballot consistent with this agreement and to permit the withdrawal of the UAPD's challlenge in Case No. S-SR-16.
