DECISION AND ORDER

Petitioner and Interested Party, California State Employees Association's (hereafter CSEA) request for reconsideration of Public Employment Relations Board's (hereafter PERB or Board) Orders Nos. Ad-100-H and Ad-101-H is hereby DENIED. The Board

finds no extraordinary circumstances as required under PERB rule 32410(a).¹

CSEA's request that certain decisions of the hearing officer and regional director concerning its standing in the University of California unit determination hearings Phase II be reconsidered should, in light of PERB Order No. Ad-101-H, be raised with the appropriate hearing officer and regional director.

¹The relevant portion of California Administrative Code, title 8, section 32410 provides:

(a) Any party to a decision of the Board itself may, because of extraordinary circumstances, file a request to reconsider the decision with the Board itself within 10 days following the date of service of the decision.
