DECISION

This case is before the Public Employment Relations Board (hereafter Board) on an appeal by the Placerville Union School District (hereafter District) to the attached determination by the regional director of the Board's Sacramento Regional Office that impasse existed between the District and the Placerville Elementary Educators Association, CTA/NEA (hereafter Association).

FACTS

On October 26, 1981,¹ the Association requested that the regional director declare impasse. On November 3, the regional

director declared that impasse existed. The District appealed that determination on November 11. Thereafter, on November 19, the District, by letter, informed the regional director that the parties were in agreement that, as of November 16, an impasse did in fact exist and requested the appointment of a mediator. By that same letter, the District stated that it was not abandoning the instant appeal.

The parties currently agree that an impasse existed as of November 16. There are no other matters before the Board relating to negotiations between the parties. The District offers no reason why a determination of the original appeal is necessary. Thus, we find that the issue as to whether impasse existed on November 3 is moot and that it is not necessary to address the issue raised by the District's appeal.

ORDER

For the reasons set forth in the foregoing Decision, the Board hereby DISMISSES the instant appeal.
