Request for Proposals (RFP)
2016 Puget Sound Maritime Emissions Inventory

The Northwest Seaport Alliance (NWSA) is soliciting proposals from firms qualified and interested in updating the Puget Sound Maritime Emissions Inventory (PSEI).

By responding to this RFP, the Proposer agrees that he/she has read and understands the requirements and all documents within this RFP package. See Attachment A for additional instructions.

A. BACKGROUND

NWSA: The NWSA is a marine cargo operating partnership of the Ports of Seattle and Tacoma. Combined, the ports are the fourth-largest container gateway in North America. The NWSA regional marine cargo facilities are a major center for bulk, breakbulk, project/heavy-lift cargoes, automobiles and trucks.

By submitting a Proposal, the Proposer represents that they have carefully read and agree to be bound by the NWSA's Standard Terms and Conditions. Identify, during the question submittal and response period, any sections you consider onerous, clarify why you consider these sections onerous, propose alternative language and describe why it is in the NWSA's best interests to adopt the alternative language.

The NWSA's Standard Terms and Conditions are included as Attachment B to this RFP.

PSEI: In 2005, the partners in the Puget Sound Maritime Air Forum, consisting of the Port of Anacortes, Port of Everett, Port of Olympia, Port of Port Angeles, Port of Seattle, Port of Tacoma, Washington State Ferries, Puget Sound Clean Air Agency, Western States Petroleum Association, Pacific Merchant Shipping Association, and others, collaborated on the development of a baseline PSEI. The baseline 2005 PSEI formed the basis of a Northwest Ports Clean Air Strategy (Clean Air Strategy). This was a collaborative approach led by the Ports of Seattle and Tacoma in Washington State and the Port of Vancouver in British Columbia, to reduce maritime, port-related emissions that affect air quality and climate change in the Pacific Northwest.

The 2011 PSEI update consisted of the same Puget Sound Airshed boundary delineated in the 2005 PSEI, and the quantitative results were evaluated against the 2005 baseline emission inventory to assess the effectiveness of the emission reduction activities and air quality improvement progress made since January 2006. The 2011 PSEI provided the benchmark for future emission reduction efforts by Ports, the marine industry, and the regulators.

The NWSA is requesting proposals to complete a 2016 PSEI emission inventory including data collection, emission calculations, and a final report. As part of the emission inventory development, the consultant should develop an emissions scenario tool as described in section C.8 and Attachment E of this request for proposal. The purpose of the tool is to test “What-If” scenarios to evaluate the effectiveness of potential emission reduction projects or initiatives.

B. SCOPE OF SERVICES

The NWSA is requesting written proposals and pricing from firms, teams, and/or individual respondents to provide consulting services to conduct the 2016 Puget Sound Marine Emissions Inventory update for the same Puget Sound Airshed boundary delineated in the 2005 and 2011 PSEI. Quantitative results will be evaluated against the 2005 baseline and the 2011 benchmark to assess the effectiveness of the emission reduction and air quality improvement progress made. As a result of this Request For Proposal, the NWSA expects to issue one contract to a consulting firm, team, and/or individual respondent.

The purpose of the PSEI is to quantify air emissions related to maritime activities in the Puget Sound Airshed which occurred in calendar year 2016 and to compare results to the 2005 baseline and the 2011 benchmark emission inventory. Fugitive emissions will not be considered in this inventory.

In responding to this Request for Proposal, the Consultant should review the 2005 and 2011 methodology and provide costs associated with calculating an updated 2016 PSEI for each sector and for each Port for that sector, using current data and throughputs. The 2005 and 2011 PSEI may be reviewed at the following location:

C. PROJECT DELIVERABLES

1. **Summarize the methodology used in the 2005 and 2011 PSEI and recommend revisions as needed.**

Prior to January 31, 2017, the Consultant will meet with the Puget Sound Marine Emissions Inventory Project Funding Committee, hereafter, the "Project Funding Committee" (a team representing each participating entity) and individually as "Members," and summarize the methodology used to generate the 2005 and 2011 PSEI. The Consultant will identify any potential gaps or flaws in the previous methodology and recommend any significant changes to the methodology. Consistency with the previous inventory is desired, unless there are significant issues or concerns that would arise from duplicating the previous methodology. Methodology must incorporate the need for data outputs to be made available in a format and level of detail suitable for submittal to EPA for the National Emission Inventory (NEI) (please see Attachment C for NEI data output and format requirements).

2. **Finalize 2016 emission calculation methodology and data collection procedures.**

Prior to February 13, 2017, the Consultant will meet with the Project Funding Committee to finalize the following:

- a. Finalize the boundaries of the inventory. It is expected that the boundaries of the inventory will be identical to the 2011 inventory.
- b. Finalize methodology for emission inventories for each of the following pollutants (data outputs must be in a format and level of detail suitable for submittal to EPA for the National Emission Inventory (NEI). Please see Attachment C for NEI data output and format requirements):
 - i. Nitrogen Oxides (NOX)
 - ii. Volatile Organic Compounds (VOCs)
 - iv. Particulates (PM2.5, PM10, diesel particulate matter (DPM10) and Black Carbon)
 - v. Carbon monoxide (CO)
 - vi. Sulfur dioxide (SO2)

vii. Greenhouse Gas (GHG) emissions from maritime combustion sources including:

- Methane
- Carbon dioxide
- Nitrous oxide

Resultant GHG emissions will be expressed in carbon dioxide equivalents and will include direct emissions only.

Because other GHG emissions do not result from maritime combustion activities, or they are deemed insignificant, the following GHGs are excluded from the scope of the Consultant:

- Sulfur hexafluoride
- Hydrofluorocarbons
- Perfluorocarbons

- c. Finalize the scope of data to be collected by the Consultant and what assistance is necessary from Project Funding Committee.
- d. If the final 2016 methodology is different from 2005 and 2011 methodology, propose a methodology to the Funding Committee for updating the prior 2005 and 2011 emission inventory.

3. **Data Collection**

The Consultant will be responsible for data collection, and will need to coordinate the data collection efforts with data providers.

The Consultant will coordinate data collection efforts with the tenant/data source providers associated with the facilities and activities described in the tables included in Attachment D. Coordination includes initial contact with the tenants/data source providers, a template for the tenants/data source providers to complete, brief discussion on the data sets to ensure that the tenants/data source providers understand what is needed, address questions from the tenant/data source providers and field questions and status request from the project manager.

The Consultant will review the data for gaps and obvious inconsistencies, and communicate with the tenants/data source providers any questions or clarifications regarding the data. The Consultant will move the data into Microsoft Excel if the data is not already in that format.

The Consultant will complete data collection by the end of the 1st Quarter 2017 unless an alternate schedule is approved by the Project Funding Committee.

Data or information provided by a third party under a confidentiality agreement must be approved by the Project Funding Committee prior to purchase or use.

4. Data Review and Progress Reports

The Consultant will review PSEI progress on a monthly basis and prepare methodology and data collection analysis reports. A monthly report will be submitted to, and reviewed with, the NWSA Project Manager. A quarterly summary report, including recommendations, will be presented to the Project Funding Committee during the last month of each quarter. The Consultant will flag any data gaps or data that does not seem reasonable and notify the Project Funding Committee. If the Consultant determines that a flaw significantly impacting the analysis is present at any time during review process, the Consultant will immediately notify the NWSA Project Manager of the flaw and make recommendations for immediate action.

5. Meetings

The Consultant will attend meetings with the Project Funding Committee, NWSA Project Manager or technical workgroups via conference calls or in person as requested by the NWSA Project Manager until the project is completed. Meetings are not expected to exceed 90 minutes in length and may occur twice per month. All meetings with the Project Funding Committee Members, or project stakeholders, by phone or in person, must be approved by the NWSA Project Manager.

6. Complete 2016 PSEI and update 2005 and 2011 PSEIs

The Consultant will calculate emissions and complete the 2016 and update the prior 2005 and 2011 emissions inventories using the methodologies agreed upon in Task 2.

7. Draft and Finalize Report

The Consultant will review the 2011 & 2005 PSEI report and provide a 2016 PSEI report comparable in context and content. The 2016 PSEI will include emissions comparisons to the 2005 and 2011 PSEI for each organization, site, and region reported in the previous inventory.

The Consultant will provide an outline of the report for the Project Funding Committee to consider. The consultant will consider that the audience for the PSEI is both technical and non-technical and that the report needs to be clearly written with graphics to illustrate trends, relative contributions of each source, broken out by sector and port. The Consultant will clarify what goes into appendices vs. in main body of document.

The Consultant will deliver up to three (3) draft PSEI reports and solicit comments from the Project Funding Committee and technical reviewers selected by the Project Funding Committee. The report should include all methodologies, assumptions, and references for all values used in the models and calculations used in developing the emission inventory. These assumptions and references can be included as an appendix and do not need to be in the main body of the report.

The Consultant will prepare a final PSEI report by the end of the 3rd quarter 2017, and provide one (1) electronic (PDF file on CD) and one (1) hard copy (bound, color and double-sided on recycled products) to the NWSA Project Manager.

The Consultant shall also provide all Members a copy of the document in unprotected Microsoft Word format so that parts of the report can be easily copied into other documents as needed by the Members.

8. Documentation

The Consultant is to include in the report a description of methodologies, assumptions and references for all values used in models and calculations.

Sufficient documentation must be provided by the Consultant so recipients can understand how emissions were calculated and can reproduce the emission calculation.

Whether as a separate document or as part of an Emissions Scenario Tool, the Consultant is to provide the following in a commonly used format¹ :

- a. All factors used in calculating emissions for each piece of equipment including activity factors, emission factors, and other relevant factors, and all documentation of all factors used.
- b. All detailed emissions calculations.
- c. All tabular data included in appendices (e.g., Appendix B in the 2011 inventory) in a format commonly used for data processing and analysis

The Consultant is to provide all model input and output files for all models used in determining emissions, emission factors or anything related to emissions (any non-default settings should be identified).

The emissions estimates are also to be provided in a format and level of detail suitable for submittal to EPA for the National Emission Inventory. Please see Attachment C for NEI data output and format requirements.

9. Emissions Scenario Evaluation Tools

For the purpose of this project, the emissions scenario evaluation tool is defined as a tool used to estimate the effect of speculative changes in operating or equipment parameters on the 2016 inventory results. The purpose of the tool is to test “What-If” scenarios to evaluate the effectiveness of potential emission reduction projects or initiatives.

The Consultant is to provide a scenario evaluation tool that is populated with all emission inventory data in a format that provides the Project Funding Committee Members the capability to estimate emissions based on data input changes from individual sources and source categories included in the 2016 PSEI. The desired capabilities of the tool are listed below. The consultant is required to complete and submit the Scenario Tool Requirements Form included as Attachment E.

- a. Save multiple scenarios.
- b. Determine emissions from each sector, each port, each sector of each port and an overall for the region.

List of Sectors

- Transiting OGVs
- Berth OGVs
- Harbor Craft (See attachment C, “Template HC tab” for a list of Harbor Craft types)
- Locomotives
- Heavy Duty Vehicles (Drayage Trucks)
- Cargo Handling Equipment
- Fleet Vehicles

- c. Be able to update or modify the inputs for any specific source (such as Vehicles/Vessels) included in the emission inventory.
- d. Be able to calculate changes for groups of vehicles/vessels by changing activity levels (hours of operation or fuel used), efficiency of engines (engine age or engine tier), and fuel type
- e. Be able to calculate changes by using a control factor.
- f. Can be populated with 2005 and 2011 data

D. PROPOSAL ELEMENTS & EVALUATION CRITERIA:

Proposals should present information in a straightforward and concise manner, while ensuring complete and detailed descriptions of the proposing team (to include the prime, key team members and major sub-consultants) and the team's ability to meet the requirements and provide the requested services of this RFP. The written proposals should be prepared in the same sequential order of proposal criteria as outlined below.

Proposals are limited to 8 numbered pages (8 ½ by 11 inch) **excluding** the cover letter, compensation information and all appendices. All pages shall be in portrait orientation with 1 inch (1") margins. Font size shall be 11 point or larger. Proposals that do not follow this format may be rejected.

The cover letter shall include the RFP Title and Number, Name, Title, Email Address, Phone Number and current Address of the submitting firm's main contact as well as the following:

Describe any claim submitted by any client against the prime firm within the past two years related to the professional services provided by the firm or its key personnel. For purposes of this request, "claim" means a sum of money in dispute in excess of 10% of the firm's fee for the services provided.

Describe any real or perceived conflicts of interests for team members, inclusive of the prime, sub-consultants and key team members.

Proposals are to address, and will be evaluated upon, the following criteria using a point system method of award:

1. INITIAL EVALUATION PHASE

a. Specialized Knowledge & Experience..... 35 PTS

- i. Ability and capacity of the firm and staff to perform the services requested in the scope of work.**

Identify the proposed team; demonstrate the team's knowledge and experience of the firm in performing marine air emission inventory work or similar work with tasks relevant to this proposed project. Include education, registrations, certifications and experience with marine air emission inventories.

Demonstrate the firm's ability to provide clear, concise, document that is comprehensible to both technical and nontechnical audience. Resumes of the key individuals may be included as an appendix and are not included in the total page count. Resumes are to be limited to one single-sided, letter-size page. Resumes exceeding this limit will not be reviewed.

The NWSA evaluators will evaluate the experience, technical competence and qualifications of the Key Personnel identified, their project specific roles and responsibilities, and overall organization of the project team. Emphasis will be placed on experience and expertise in performing work of similar scope and complexity.

ii. Experience with performing marine air emission inventory work or similar work with tasks relevant to this proposed project.

Include a list of recent projects in the last three years, to include a point of contact, contact information, and brief description, for services relevant to the items listed in the Scope of Services as performed by the key personnel. Only projects completed by members of the project team will be considered.

Provide examples of emissions scenario evaluation tools developed by the consultant for agencies to conducting maritime emission "What If" analysis. Only projects completed by members of the project team will be considered.

b. Project Approach Narrative.....25 PTS

Submittals should clearly outline the team's recommended approach and methodology for accomplishing the Scope of Services. Clearly describe the approaches and methods that will be used to accomplish the tasks required in the scope of services. Include commitment of the firm to meet scope, schedule, and budget.

Submittals should clearly outline the team's recommended approach for data collection and data quality assurance.

Submittals should include a final work product from previous project showing the ability to present complicated information to a broad audience. For large documents, a link to a website or File Transfer Protocol (FTP) site is acceptable.

Submittals should include a schedule that provides a clear example of the team's availability and how the team will meet the NWSA's timeline.

c. Coordination & Communications15 PTS

Provide a plan for communications and coordination between the Project Funding Committee, NWSA's project manager and the various stakeholders.

Provide information that shows the ability of the firm and the assigned team to communicate and work effectively with client firms, regulators and other stakeholders involved in the work.

d. Compensation25 PTS

Compensation information MUST be provided separately from the proposal, in an individual document.

All rates quoted shall be:

- Firm, fully burdened, including, but not limited to, per diem, administrative overhead, travel, lodging, and transportation (all direct/indirect expenses included);
- Full cost inclusive of sales tax and other government fees, taxes and charges; and
- Valid throughout the contract period unless otherwise amended and agreed to by both parties in writing.

Provide a Cost for each of the following items:

- Task 1: Summarize the methodology used in the 2005 and 2011 PSEI and recommend revisions as needed.
- Task 2: Finalize 2016 emission calculation methodology and data collection procedures.
- Task 3: Emission Calculation
- Task 4: Data Review and Progress Report
- Task 5: Meetings
- Task 6: Complete 2016 PSEI and update 2005 and 2011 PSEIs
- Task 7: Finalize Report

- Task 8: Documentation
- Task 9: Emissions Scenario Evaluation Tool

Successful firms will be compensated according to a mutually acceptable fee structure. Please attach to your Proposal detailed information on the firm's proposed fee structure for the services proposed, for all fees, charges, expenses, etc. All rates quoted shall be full cost inclusive of sales tax and other applicable government fees, taxes and charges.

2. FINAL EVALUATION PHASE (if applicable)

- a. Interviews (as requested by the NWSA).....100 PTS

If an award is not made based on the written evaluations alone, interviews may be conducted with the top-ranked proposers. Failure to participate in the interview process will result in the Proposer's disqualification from further consideration. Travel costs will not be reimbursed for the interview.

- b. References (as requested by the NWSA).....50 PTS

If an award is not made based on the written evaluations and interviews, reference checks may be performed on the selected firm. The Evaluation Team may evaluate the reference checks to assess the proposed team's overall performance and success of previous, similar work. Reference checks may also be utilized to validate information contained in the proposal.

Proposers who, relative to this scope of services, contact any individuals or Commission members representing the NWSA, other than the Procurement Representative listed on the RFP may be disqualified from consideration.

Proposers who may have questions about provisions of these documents are to email their questions by the date listed above. The NWSA will respond to all written questions submitted by this deadline.

ADDENDA

The NWSA may make changes to this Solicitation. Oral or other interpretations, clarifications or submittal instructions will be without legal effect. Any information modifying a solicitation will be furnished in a formal, written addendum. If at any time, the NWSA changes, revises, deletes, increases, or otherwise modifies the Solicitation, the NWSA will issue a written Addendum to the Solicitation. Addenda will be posted to the Port of Tacoma's web site and conveyed to those potential submitters who have requested to be placed on the Holder's List.

SUBMITTAL PROCESS

Please submit proposal, including all appendices and compensation in separate Adobe Acrobat PDF format. Submittals need to be limited to **9 MB in total email size**. It is the Consultant's responsibility to verify the receipt of the submittal. Electronic verification will be provided upon request.

***Late proposals will not be accepted by the NWSA. Proposals received after the stated date and time will not be reviewed and shall be deemed non-responsive.**

All proposals submitted shall be valid and binding on the submitting firm for a period of ninety days following the Proposal submittal deadline and for any extension of time granted by the submitting firm.

EVALUATION AND AWARD PROCESS

An evaluation team will review each proposal and evaluate all responses received based upon the criteria listed herein. The NWSA may request clarifications or additional information, if needed. After the evaluation team individually scores each proposal, the scores are tallied and the firms are ranked based on the scores.

A selection may be made based on the proposals and initial evaluation criteria alone. Alternatively, the evaluation team may create a short list of the top ranked firms and invite the short listed firms in for interview and/or check references. Scores for reference checks and interviews will be tallied and added to the short listed firm's initial evaluation scores. Final selection will be based on reference checks and interviews.

The NWSA intends to select the Proposer who represents the best value to the NWSA and begin the negotiation and award process based on the evaluated scores.

The selected Consultant will be invited to enter into contract negotiations with the NWSA. Should the NWSA and the selected firm(s) not reach a mutual agreement, the NWSA will terminate negotiations and move to the next highest ranked firm and proceed with negotiations.

The NWSA reserves the right to accept or reject any or all information in its entirety or in part and to waive informalities and minor irregularities and to contract as the best interest of the NWSA may require. The NWSA reserves the right to reject any or all Proposals submitted as non-responsive or non-responsible.

Procedure When Only One Proposal is received

In the event that a single responsive proposal is received, the Proposer shall provide any additional data required by the NWSA to analyze the proposal. The NWSA reserves the right to reject such proposals for any reason.

GENERAL INFORMATION

News releases pertaining to this RFP, the services, or the project to which it relates, shall not be made without prior approval by, and then only in coordination with, the NWSA.

COSTS BORNE BY PROPOSERS

All costs incurred in the preparation of a Proposal and participation in this RFP and negotiation process shall be borne by the proposing firms.

SMALL BUSINESS AND DISADVANTAGED BUSINESS OPPORTUNITIES

The NWSA encourages participation in all of its contracts by MWBE firms certified by the Office of Minority and Women's Business Enterprises (OMWBE). Participation may be either on a direct basis in response to this solicitation/invitation or as a subcontractor to a Bidder/Proposer. However, unless required by federal statutes, regulations, grants, or contract terms referenced in the contract documents, no preference will be included in the evaluation of bids/submittals, no minimum level of MWBE participation shall be required as a condition for receiving an award and bids/submittals will not be rejected or considered non-responsive on that basis. Any affirmative action requirements set forth in federal regulations or statutes included or referenced in the contract documents will apply. The selected firm will be required to show evidence of outreach.

PUBLIC DISCLOSURE

Proposals submitted under this Solicitation will be considered public documents and, with limited exceptions, will become public information and may be reviewed by appointment by anyone requesting to do so following the conclusion of the evaluation, negotiation, and award process. This process is concluded when a signed contract is completed between the NWSA and the selected Consultant.

If a firm considers any portion of its response to be protected under the law, the vendor shall clearly identify each such portion with words such as "CONFIDENTIAL," "PROPRIETARY" or "TRADE SECRET" on each page for which the protection is sought. If a request is made for disclosure of such portion, the NWSA will notify the vendor of the request and allow the vendor not less than ten (10) days to seek a protective order from the Courts or other appropriate remedy and/or waive the claimed confidentiality. Unless such protective order is obtained and provided to the NWSA by the stated deadline, the NWSA will release the requested portions of the Proposals. By submitting a response the vendor assents to the procedure outlined in this paragraph and shall have no claim against the NWSA on account of actions taken under such procedure.

Northwest Seaport Alliance Terms And Conditions Personal Services Agreement

In consideration of the mutual covenants, obligations, and compensation to be paid by the NWSA to Consultant, it is agreed that:

1. Key Personnel

The Consultant and/or its subconsultants' key personnel, as described in its Consultant selection submittals, shall remain assigned for the duration of the Project unless otherwise agreed to by the NWSA.

2. Relationship of the Parties

Consultant, its subconsultants and employees, is an independent Contractor. Nothing contained herein shall be deemed to create a relationship of employer and employee or of principal and agent.

3. Conflicts of Interest

Consultant warrants that it has no direct or indirect economic interest which conflicts in any manner with its performance of the services required under this Agreement. Consultant warrants that it has not retained any person to solicit this Agreement and has not agreed to pay such person any compensation or other consideration contingent upon the execution of this Agreement.

4. Compliance with Laws

Consultant agrees to comply with all local, state, tribal and federal laws and regulations applicable to the project, including building codes and permitting regulations existing at the time this Agreement was executed and those regarding employee safety, the work

place environment, and employment eligibility verifications as required by the Immigration and Naturalization Service. Consultant shall obtain all professional licenses and permits required to complete the scope of work as defined.

5. Records and other Tangibles

Until the expiration of six years after the term of this Agreement, Consultant agrees to maintain accurate records of all work done in providing services specified by the Agreement and to deliver such records to the NWSA upon termination of the Agreement or otherwise as requested by the NWSA.

6. Ownership of Work

The services to be performed by Consultant shall be deemed instruments of service for purposes of the copyright laws of the United States. The NWSA has ownership rights to the plans, specifications, and other products prepared by the Consultant. Consultant shall not be responsible for changes made in the models, programs, reports or other products by anyone other than the Consultant. Consultant shall have free right to retain, copy and use any tangible materials or information produced but only for its own internal purposes. Use of models, programs, reports or other products prepared under this Agreement for promotional purposes shall require the NWSA's prior consent.

7. Disclosure

All information developed by the Consultant and all information made available to the Consultant by the NWSA, and all analyses or opinions reached by

the Consultant shall be confidential and shall not be disclosed by the Consultant without the written consent of the NWSA.

8. Compensation

As full compensation for the performance of its obligations of this Agreement and the services to be provided, the NWSA shall pay Consultant as specified in the Agreement.

9. Payment Schedule

Consultant shall submit detailed numbered invoices showing contract number, description of work items being invoiced, title of project, total authorized, total current invoice, balance of authorization, hours, hourly rate by the 10th of the month to be paid by the end of the current month, unless other terms are agreed to by the parties.

10. Costs and Disbursements

Consultant shall pay all costs and disbursements required for the performance of its services under this Agreement.

11. Insurance - Assumption of Risk

a) As a further consideration in determining compensation amounts, the Consultant shall procure and maintain, during the life of this Agreement, such commercial general and automobile liability insurance as shall protect Consultant and any subconsultants performing work under this Agreement from claims for damages from bodily injury, including death, resulting there from as well as from claims for property damage which may arise under this Agreement, whether arising from operations conducted by the Consultant, any subconsultants, or anyone directly or indirectly employed by either of them.

b) With respect to claims other than professional liability claims, Consultant and its subconsultants agree to defend, indemnify and hold harmless the NWSA, its appointed and elective officers and its employees from and against any and all suits, claims, actions, losses, costs, penalties and damages of whatever kind and nature, including attorney fees and costs by reason of any and all claims and demands on it, its officers and employees, arising from the negligent acts, errors or omissions by the Consultant in the performance of the Consultant's professional services.

c) With respect to professional liability claims only, Consultant and its subconsultants agree to indemnify and hold harmless the NWSA, its appointed and elective officers and its employees from and against any and all suits, claims, actions, losses, costs, penalties and damages of whatever kind and nature, including attorney fees and costs by reason of any and all claims and demands on it, its officers and employees, arising from the negligent acts, errors or omissions by the Consultant in the performance of the Consultant's professional services.

12. Standard of Care

Consultant shall perform its work to conform to generally accepted professional standards. Consultant shall, without additional compensation, correct or revise any errors or omissions in such work.

13. Time

Time is of the essence in the performance by the Consultant of the services required by this Agreement.

14. Assignability

Consultant shall not assign any interest in this Agreement and shall not transfer any interest in the Agreement to any party without prior written consent of the NWSA.

15. Term of this Agreement

The effective dates of this Agreement are as specified. This Agreement may be terminated by the NWSA for cause when the NWSA deems continuation to be detrimental to its interests or for failure of the consultant to perform the services specified in the Agreement. The NWSA may terminate this Agreement at any time for government convenience in which case it shall provide notice to the Consultant and reimburse the Consultant for its costs and fees incurred prior to the notice of termination.

16. Disputes

If a dispute arises relating to this Agreement and cannot be settled

through direct discussions, the parties agree to endeavor to settle the dispute through a mediation firm acceptable to both parties, the cost of which shall be divided equally. The NWSA reserves the right to join any dispute under this Agreement with any other claim in litigation or other dispute resolution forum, and the Consultant agrees to such joinder, so that all disputes related to the project may be consolidated and resolved in one forum. Venue for any litigation shall be the Pierce County Superior Court of the state of Washington and the prevailing party shall be entitled to recover its costs and reasonable attorney's fees.

17. Extent of Agreement

This Agreement represents the entire and integrated understanding between the NWSA and Consultant and may be amended only by written instrument signed by both the NWSA and Consultant.

Attachment C - Requirements for Reporting Puget Sound Maritime Emission Inventory data to EPA for the National Emission Inventory (NEI)

Introduction

EPA requires a level of detail and format for reporting data to them for use in the National Emission Inventory.

Below are those requirements.

Templates for each source category are found in the **template** tabs.

The proposer must provide the PSEI data in this detail and format in a spreadsheet.

TEMPLATES - Puget Sound Emission Inventory Reporting Templates

The template tabs contain the information necessary to report the emissions to EPA and become part of the National Emissions Inventory.

Use these templates to report emissions.

Emissions reporting templates (worksheets) are provided for:

OGV - Ocean-going vessels

HC - Harbor craft

CHE - Cargo-handling equipment

RR - Yard locomotives, and Line Haul locomotives on Port (don't need off-port Line Haul)

All Other - Heavy duty vehicles, light duty vehicles, pleasure craft

Source type level of detail

Except for heavy and light duty vehicles, emissions must be reported by source classification code (SCC).

The SCC codes describe sources and fuel types (see individual template worksheets).

Mode (cruise, maneuvering, hoteling, reduced speed zone) is also required.

HC are further reported by vessel type.

Geographic level of detail

OGV and HC require reporting by GIS shapes. (More information on the shapes is in the **notes_GIS** tab)

CHE and RR are reported by related port area, and rail yard.

All Other sources are reported by county.

Inapplicable rows in the templates

Not all location - source combinations in the templates exist. It is anticipated that many rows could have zero emissions.

SHAPEFILES - Shapefiles for reporting Ocean-going Vessel and Harbor Craft Emissions

Emissions must be reported by EPA shapefile ID for OGV and HC. EPA shapefiles for OGV and HC may be downloaded at:

Assigning emissions to shapefiles when there isn't a good match between the EPA shapefile and the PSEI locations:

1) Shipping Lane Emissions

Assign the arrival/departure lane emissions that lay outside the US boundary to the adjacent US county shape for ships calling at US ports. This will ensure that inbound and outbound vessel traffic associated with US ports is accounted for and no non-US vessel movements (vessel traffic to and from Canadian ports) are included in your estimates.

2) Port-related Emissions (primarily hotelling and maneuvering)

- a) If the emissions are near to the EPA shape, and don't cover a large area, assign port emissions to the closest shape for that port.
- b) If the emissions are not very near the EPA shape or cover a large area, we can work with EPA to add more shapes.

Of particular concern are locations of hotelling emissions. For Instance, in 2011 EPA modeled high risk in Clallam County because all the hotelling emissions in the county were allocated to the Port of Port Angeles, when much of the hotelling actually took place outside of port property at anchorage sites. The consultant worked with EPA and Ecology to add an additional shape to capture anchorage emissions. If this is the case in other areas, we need to add new shapes.
