 - i. Scope

- A. The accompanying Drawings and Specifications show and describe the location and type of Work to be performed under this project. Work is more specifically defined on the drawings listed in Section 00 01 15.
 - 1. The Work under this contract is to provide, furnish and install all labor, materials and equipment required to complete the work, installed, tested, and ready for use, and as described in these documents.
 - 2. The Environmental Engineered Cap Repair-Parcel 47 consists of:
 - The removal of steel debris embedded in asphalt, asphalt grinding, disposal of asphalt grindings, installation of paving fabric, and placement of asphalt pavement.

 - i. Working Facility
 - 1. Calbag Metals will remain in operation for the duration of construction. Contractor shall conduct all items of work in such a manner to prevent interference.

 - 1. Grinding will need to be taken to LRI
 - ii. Debris Disposal
 - 1. Includes removal and disposal of all debris in asphalt
 - iii. Oil Patch Areas Allowance
