




1 PLAN - TYPICAL ASSEMBLED WALE UNIT
SCALE: 1/2"=1'-0"




3 PLAN - ASSEMBLED WALE UNIT @ BENT 32


2 PLAN - ASSEMBLED WALE UNIT @ BENT 1
