Washington State Prevailing wages can only be enforced for work done or for goods produced within the State of Washington. However, if you are trucking a finished good fabricated for a Public works project using other than a common carrier, the truck driver would be paid prevailing wages from the Washington State line to the public works Site.

August 13 th is not feasible especially with the shortages in the steel market.	NTP is anticipated to be within 7 calendar days of bid opening.

There does not appear to be a shackle available that can connect the ½" chain and fit over the eyebolt or the Padeye. It would require 2 shackles at each end as an "adapter".	Additional shackles or hardware may be required depending on the selected chain and should be included in the bid". See attached pictures of existing shackle connections.
