Request Online Courses

3. The online/distance learning provider will be notified of your request and, once approved, the course will be added to your school.

6. Click **Submit**.
7. Once approved, your selected AP courses will appear on your school's AP Ledger, published annually in November.

AP Audit process for Instructors

Instructors will complete the following steps, which will allow access to the [AP Classroom](#). The AP Classroom offers instructional resources to each teacher with an approved course.

1. Log in to AP Course Audit or create an account.
2. Click + **Add Course**, then select your course.
3. Click **Complete Course Audit Form** and agree to the required statements.
4. Click **Select Textbook** and enter the textbook listed in the syllabus (see table below).
5. Click **Submit Course Document**.
6. Choose **Claim Identical to a Syllabus** and enter the approval number.
7. Upload the matching syllabus (linked below).
8. Click **Submit Syllabus Now**.

Note: For *AP Computer Science A*, select “AP Endorsed Provider Resource – CompuScholar” as the textbook. All other steps remain the same.



College Board Notes:

- AP courses from Accelerate Online Academy are intended for students in grades 9–12, except for world language courses.
- Courses must be selected from the drop-down menu on your School Status page to appear on the AP Ledger.
- Teachers must review and agree to the AP Principles and communicate them to students and parents.

Exam Administration & Course Ledger

- Schools are responsible for their own AP exam administration and ordering.
- Once registered with the College Board, exam access is available via AP Central.
- Approved AP courses cannot be removed or changed once selected—this is a College Board policy.
- To view Accelerate’s approved courses, search the AP Course Ledger using code #030682 under “High School Name or College Board School Code.”

Additional Setup

- Schools must designate a College Board administrator.
- Each teacher must create and link their own College Board account.
- For audit help, call 1-877-274-3570, option 5.

Annual Reminder

Each year, school partners must renew AP course authorization by **January 31**. Early completion ensures teachers gain timely access to AP Classroom, which offers valuable instructional resources.
