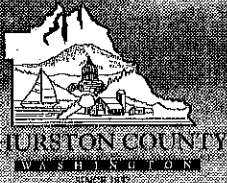

# Important Information for Thurston County Voters

## Dear Voters of Thurston County:

Following the '96 Presidential race, this year's elections bring our attention back to the local level. This September's Primary election provides you the opportunity to vote on important local offices. These elections directly affect you as a Thurston County citizen. Thus, this year's theme, **"YOUR COMMUNITY, YOUR FUTURE, YOUR VOTE!"**

As important as local races are, voter turnout is typically lower than it is with even-year elections. Without national media hype, many people forget to vote. Others simply find it difficult or impossible to make time in their busy schedules to get to the polls.

There is a solution to this dilemma, which takes just seconds to do. By filling out the form on the back page and returning it, you can become a permanent mail voter. Already, over half of our County's voters have chosen to "Ride the Wave of the Future" by voting at home! As a taxpayer, you need to know that this will save money. A study of 1995 costs revealed that mail ballots cost \$2.87 per voter, while pollsite ballots cost \$8.10 per voter.

Perhaps more important, mail voting provides you the time and opportunity to be a well-informed voter. Once you're signed up, you'll receive a ballot in the mail for every election you're eligible to vote in. No more worrying about missed elections - your ballot will arrive well before election day. Just make sure your ballot is postmarked on or before the day of the election.

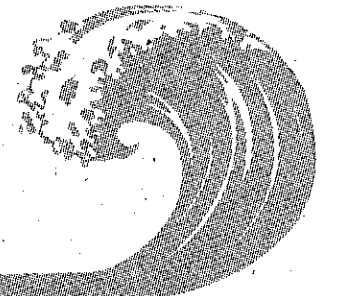
Unless you live in the 35th Legislative District, you'll be getting your Primary ballot by mail. Use this pamphlet while you vote at home. People living in the 35th District will be voting at the polls. This is because partisan elections, by law, cannot be held entirely through the mail. I encourage those living in the 35th District, who aren't signed up for permanent absentee voting, to fill out the sample ballot on pages 5-7 and bring it to the polls on September 16. The races you can vote on are determined by where you are registered.

Keep this year's theme in mind of **"YOUR COMMUNITY, YOUR FUTURE, YOUR VOTE!"** If you find that you're one of those people who has good intentions, but misses elections, try voting at home. Voting is truly the best way to have your voice heard and to have an impact on the future of your community.

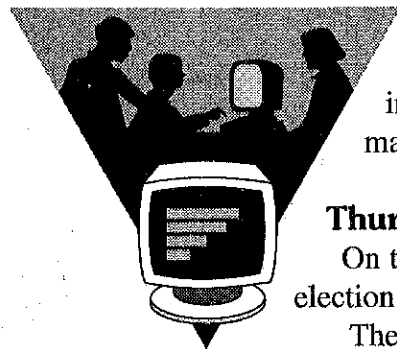

On the cyber front, the Auditor's Office will offer the Local Voters' Pamphlet, election night results, and other election information on the Internet.

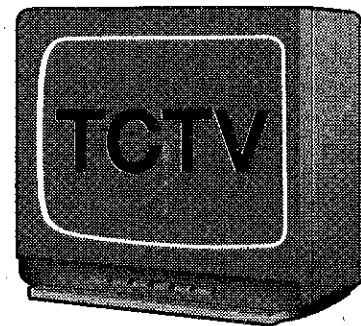

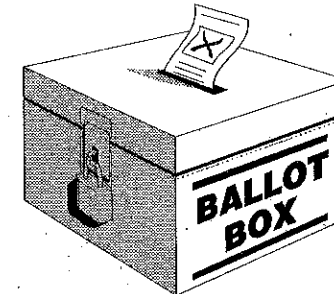
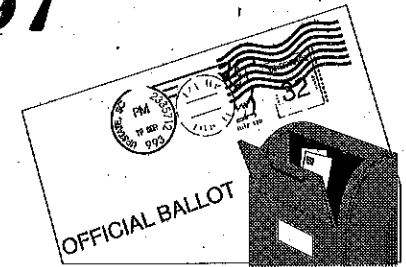

### Dear Voter,

This sample ballot contains all candidates and measures certified to appear on the September 16, Primary Election ballot. You will not be entitled to vote on all races that appear on this sample ballot. Only the contests and measures that apply to your precinct will be listed on your mail-in or absentee voter guide.



Voters in the 35th Legislative District will be voting at the polls unless they have requested an absentee ballot. Candidates' names for the 35th Senate seat are rotated to provide electoral equality. Therefore, the order of candidates' names listed on the voting booth pages and on the Absentee or Mail-In Voter Guide for the 35th Senate race, may not match this sample ballot. We strongly encourage you to mark your sample ballot and take it into the voting booth with you on election day.

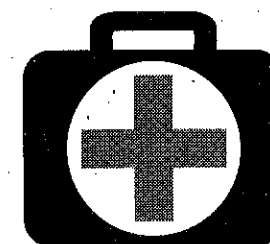

# Pollsite Voting Information

## For 35th Legislative District Voters Only

Your election is a pollsite/absentee ballot election.

(Voters who do not reside in the 35th district see page 10 for voting information.)

### Where To Vote:

Vote at your precinct's polling place. The precinct name and number are on your voter registration card. Locations of polling places are listed below. If you need further information, call the Elections Department at the number listed below.

### When To Vote:

Polls are open from 7:00 a.m. to 8:00 p.m. We suggest that you try to vote between the hours of 9:00 a.m. and 12:00 p.m. or 2:00 p.m. and 5:00 p.m. For those voters who are voting an absentee ballot and who have not mailed their ballot, ballots may be dropped off at the nearest pollsite on Election Day only.

### How To Vote:

In Thurston County, voters cast their votes by punching the correct holes in a punch-card ballot. Instructions are provided in the voting machines and with absentee ballots.

If you need assistance in casting your ballot, you may ask an election worker to explain how to use the voting device or machine.

If you are a person of disability and unable to record your vote, you may be accompanied into the voting booth by any person you choose to assist you or by two election officials, each of a different political party.

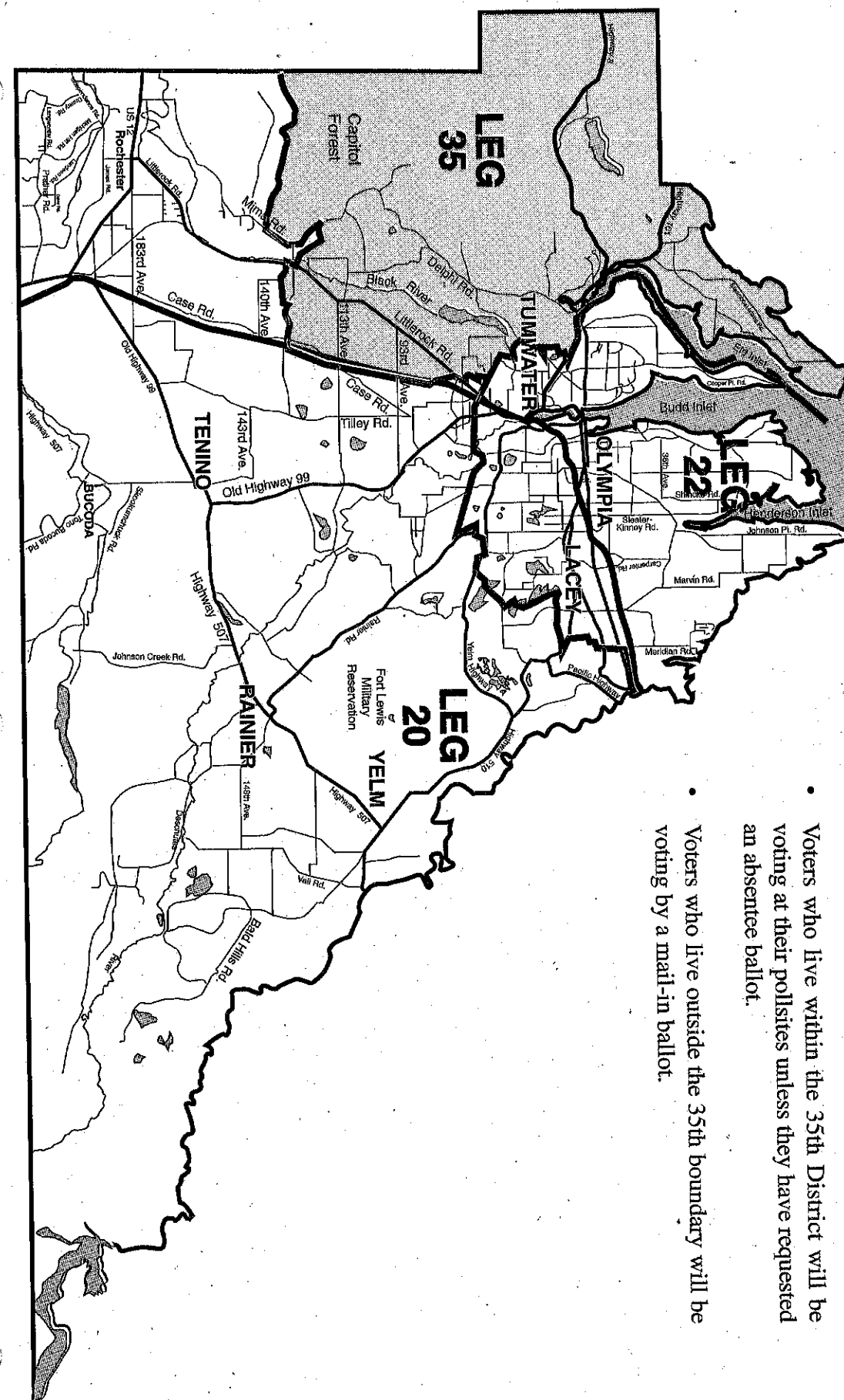

The 1997 Primary Election is a Vote-By-Mail election (excluding the 35th Legislative District). All precincts in Thurston County will be participating in this election. This type of election allows you the convenience of voting at home and simply returning your ballot by mail. *Voters are strongly encouraged to return their ballots early.* Ballots must be voted and postmarked no later than Election Day, September 16, 1997.

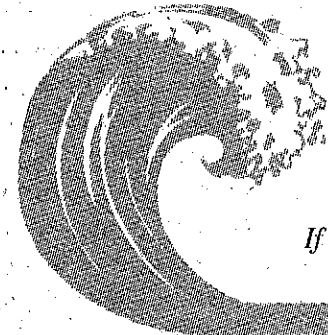

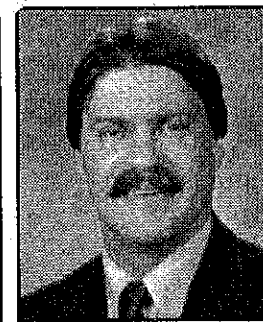

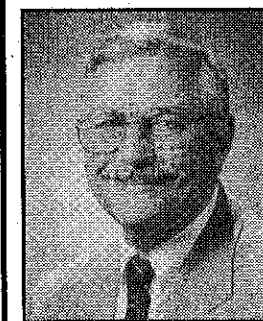
Lena's list of priorities for the next

I will work to restore local values and controls in our schools by rejecting federal mandates. I will investigate school funding, ensuring that tax dollars aren't being misdirected for other purposes.



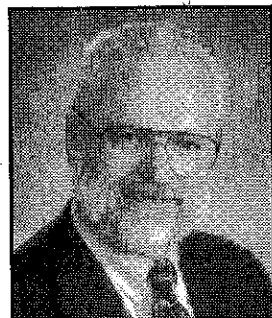
## CITY FORM OF GOVERNMENT

There are three principal forms of city government in Washington: mayor-council, council-manager, and commission.

The council is the city legislative and policy-making body. The council enacts all ordinances, resolutions, and policies, consistent with state law, for the safety and welfare of the city residents. Traffic, fire protection, police, land use, municipal services, business, and other regulations are overseen by the council. The council also controls the city finances through the budgeting and auditing processes, and by exercising general oversight.

The non-partisan council members are elected to four-year terms.

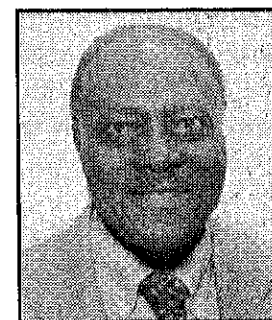
Hi, I am 34, and have lived in Lacey since 1966. I have witnessed many changes in this city.

I am very concerned about the development of Lacey as a community. We must make it safe and comfortable for our kids, and/or our future grandkids, to live here.



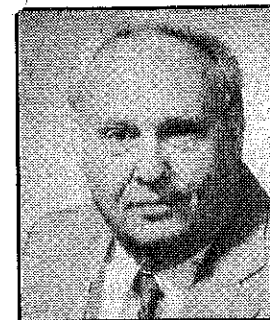

## TOWN OF RAINIER – FORM OF GOVERNMENT

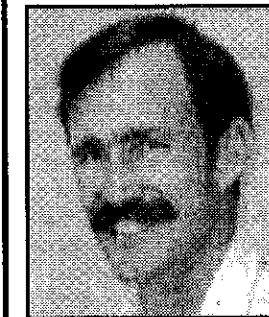
The Town of Rainier uses the mayor-council form of government.

In the Town of Rainier, the council is the town legislative and policy-making body. The council enacts all ordinances, resolutions, and policies, consistent with state law, for the safety and welfare of the town residents. Traffic, fire protection, police, land use, municipal services, business, and other regulations are overseen by the council. The council also controls the town finances through the budgeting and auditing processes, and by exercising general oversight.

The mayor is the chief executive officer and ceremonial head of the town. The mayor presides over council meetings and has veto power over ordinances.

*The non-partisan council members and mayor are elected to four-year terms.*

## SCHOOL BOARD DUTIES AND RESPONSIBILITIES

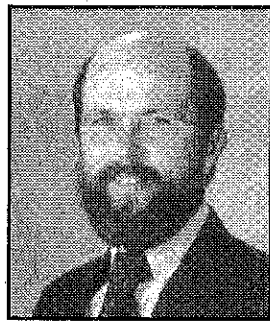
Thurston County is divided into nine separate school districts, each governed by a five-member board. The board's responsibilities include: budget, policy development, classroom instruction, planning and communications.

While the boards delegate authority for day-to-day functions to professional staff, they may never delegate ultimate responsibility.

Board members are elected in a non-partisan general election by voters within that school district. They receive no salary. A board may approve a per diem compensation for its members for attending board meetings.

Candidates must reside in the director sub-district for which they are seeking office. All candidates are elected by the voters of the entire school district.

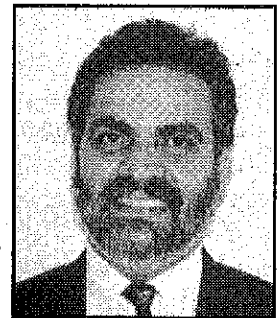

## FIRE DISTRICT DUTIES AND RESPONSIBILITIES

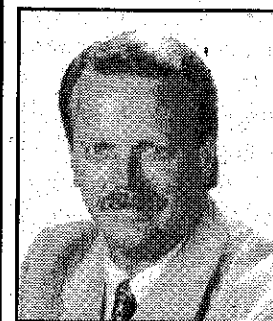
Fire protection districts are formed for the provision of fire prevention services, fire suppression, emergency medical services, and the protection of life and property in the unincorporated areas of the county. Administrative authority for the district results from decisions made by a three-member board of elected fire commissioners.

The Board of Commissioners has the authority to hire and appoint employees as well as administer all aspects of the district. The Board is required to hold regular monthly meetings.

The District, being a special purpose district, levies regular property taxes to provide services to the public. Additionally, with voter approval, the Board may issue bonds and make excess levies for specific purposes.

The voters elect Commissioners to staggered six-year terms. The non-partisan commissioners receive no regular salary, but may choose to receive nominal compensation for attending meetings.

### Statement For:

**The annual levy for the Medic One emergency medical services system deserves continued community support.** Thurston County's Medic One is a nationally recognized system which for over 23 years has provided pre-hospital emergency medical care throughout one of the state's fastest growing counties. In 1996, the Medic One system responded to 15,416 emergency calls, a 7 percent increase over 1995.

**This year's ballot issue proposes a new quick response paramedic unit** to serve the rapidly growing southwest county, improving critical response time and reducing the need to draw Medic One units away from their principal service areas. The remaining budget provides for continued service levels, with necessary increases for paramedic contracts and 911 dispatch costs. One of the state's most cost efficient systems, the estimated Medic One levy rate is about 1 cent more per \$1,000 of assessed valuation than this year's rate. This reflects a budget increase of 13.5 percent to fund the new unit and other increased costs.

**Medic One, overseen by a community council, currently provides four paramedic units** on a 24-hour basis. Medic One also supports training, supplies, and equipment for the county's 18 fire department aid crews, the first to arrive at medical emergencies. Private ambulance companies

provided fee-for-service transport to non-critical patients. This partnership allows Medic One to respond efficiently to life-threatening situations, without additional costs to the patient. We can all be proud of our Medic One system, controlled and maintained by the citizens of Thurston County.

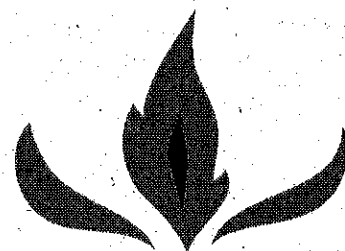

#### Why do we need approval?

We are asking for an additional \$0.50 per thousand dollars of assessed valuation. This funding will allow us to provide you with at least one full time firefighter, basic emergency medical services and a new type of paramedic unit. These dollars will pay for full time personnel and 20% of the funding needed to staff the new SPRINT unit. SPRINT is a Single Paramedic Rapid Intervention Non-Transport unit which will be stationed at Grand Mound. We also need approval of the countywide Medic One levy that will provide the other 80% of the funding.

#### Why do we need it?

Aid calls to the paramedics countywide have exceeded all previous projections (up 11% over '96 alone). More calls result in longer response times. SW Thurston County waits longer for paramedic services due to our distance from the four current units. Countywide the average response time is 9.75 minutes; however, SW Thurston citizens wait an average of 20 minutes for a paramedic unit. Each passing minute decreases a cardiac arrest victim's chances by 6-7%. (sixteen cardiac arrests in 1996)

#### The new unit will:

Provide minimal full time personnel to respond to your fire and medical emergencies. It will provide

for 24 hour personnel to operate the SPRINT unit and cut response times in half for the majority of the 700 paramedic responses expected in SW Thurston Co. in 1998.

#### What will it cost?

This levy lid increase will cost \$0.50 per thousand dollars of assessed valuation. The owner of a home assessed at \$100,000 would pay an increase of only \$4.17 per month.

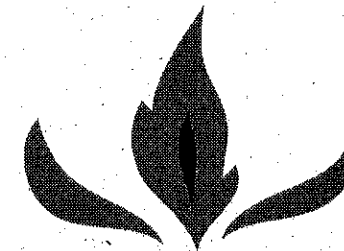

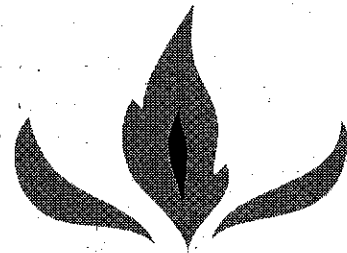

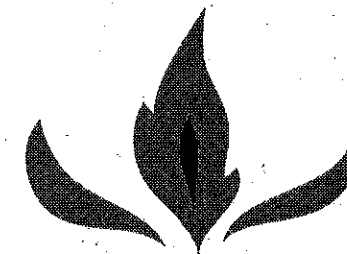

## Voter Registration Information

### Voter Qualifications

To register to vote, you must be:

- A citizen of the United States
- A legal resident of Washington State
- At least 18 years old by election day

In the state of Washington, you do not have to register by political party or declare party membership to vote in the state's regular primary or general elections.

### Registration Deadlines for New Applicants

You may register to vote at any time. State law requires you to register at least 30 days before an election if you wish to vote at a polling place.

If you miss the 30 day registration deadline, you may register between 30 and 15 days before an election. Listed are the following requirements: you must be a resident at the same address for at least 30 days prior to an election; you must register in person at the Auditor's Office; and you must vote an absentee ballot. If you register after the 15 day deadline, your registration will be processed for the next election.

### Where to Register

You may call and request a mail-in voter registration form from the Auditor's Office at any time. Also, you may obtain forms at the following locations:

### Change of Residence

If you move to a **new** county, you must complete a new voter registration form. (See "Registration Deadlines for New Applicants.")

To be eligible to vote in your new precinct, you must re-register or update your registration at least **30 days** before an election.

### Change of Name

You may use the mail-in registration form to change your name. If requested, our office will mail a form directly to you. You may also change your name by completing a form when you renew your driver's license at the Department of Licensing, Driver's License Division, 645 Woodland Square Lp SE, Lacey.

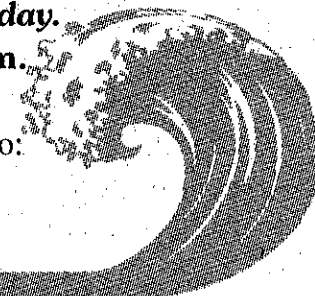

## Requesting an Absentee Ballot for the September 16 Primary Election

An absentee ballot request form for the September 16 Primary Election is located on the back page of this pamphlet. If you are already an ongoing absentee voter, you **do not** need to complete this form. You will automatically receive a ballot for this election providing our office has your current residential/mailling address. Call our office if you have any questions about your absentee ballot status.

### Complete the form for the following reasons only:

- You live in the 35th Legislative District and want to vote by an absentee ballot.
- You will be out of town prior to election day.  
(Primary election ballots will begin delivery on September 2.)
- You wish to become an ongoing absentee voter. (If so, be sure to sign the "Ride the Wave of the Future – Vote at Home" area located on the back page.)
- You wish to use this form to change your voter registration address. You must be a registered voter and moving within Thurston County to use this form. (Please be sure to check the "New Permanent Address" box or complete the change of address form on page 28.)

### For Military Members, Overseas Citizens, and Hospitalized Voters

1. *Service Absentee Ballot:* Members of the military service and their dependents may apply for an absentee ballot at any time.
2. *Special Absentee Ballot:* A voter who is outside the continental United States at election time and will be unable to return a regular absentee ballot by normal mail delivery, may apply for a special absentee ballot up to 90 days before an election. The special absentee ballot will contain the known offices and measures scheduled to appear on the ballot.
3. *Emergency Health Clause:* If you are confined to the hospital and were admitted no earlier than five days before an election, you may apply for an absentee ballot up to and including the day of the election. Contact the hospital administrator or County Auditor for such a ballot.

### Please Note...

- Any voter may request an absentee ballot, in person, by telephone (360) 786-5408, by mail, or by fax (360) 786-5223.
- Submit your request at once to allow time for a correspondence exchange.
- If you have any absentee related questions, please call our office at (360) 786-5408.

**All ballots must be voted and postmarked no later than the day of the election.**

# Have You Caught the Wave?

Since the 1993 vote-by-mail Primary election, Thurston County voters have been *Riding the Wave of the Future*, that is, *voting by mail*; and voting by mail is changing the way elections are conducted.

In 1993, permanent absentee voters made up only 4% of the total registered voters in our county. Currently, an incredible 55% of Thurston County voters automatically receive a ballot by mail for every election.

In the last two pollsite elections in Thurston County, over 70% of the ballots were cast by mail.

It cost 22% more to conduct the 1994 general election at the polls than the comparable 1995 general vote-by-mail election. The additional costs in a pollsite election come from hiring and training board workers, leasing polling places, and preparing supplies.

For every future pollsite election, over half of the voters will receive a ballot in the mail automatically. That's because over 1/2 of Thurston County voters have *Caught the Wave* and are permanent absentee voters!

Thurston County has consistently reduced the cost of conducting elections by mail since September 1993. This has been accomplished by streamlining procedures, working with agencies to be more efficient, and improving the process of preparing ballots for counting.

There were 27 counties (out of 39) in the state that chose to conduct the June 17 Stadium Election by mail. Across the state, comparable vote-by-mail counties had significantly higher turnout than their pollsite counterparts. For example, Garfield County's *vote-by-mail* election turnout was 63.53%; compared to adjacent Asotin County's *pollsite* election turnout which had a low 17.99%.

In response to the popularity of voting by mail, the Auditor's Office continues to keep costs down. As pollsite turnout declines and voting by mail increases, we plan to reduce expenses related to pollsite voting by consolidating election boards and polling sites wherever possible. We conduct elections by mail whenever possible as well.

If you would like to *Ride the Wave of the Future – Vote at Home* and are not currently on permanent absentee voting status, fill out the form on the back page and return it to the Auditor's Office.

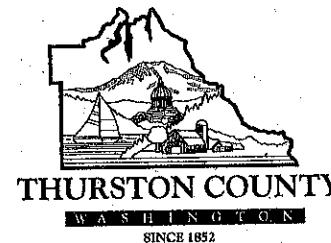
