Statement of Need

BOCC is requesting 2 new Public Information Specialists to meet the needs of the expansion of the Board of County Commissioners from three to five.

The public information office of two already stretched thin, the public information supervisor is proposing to add an additional PIS to focus on internal communications. Duties would include internal communications focus, media contact – tertiary, develop and implement internal communications plan – to include annual report, produce Thurston Insider, support BoCC programs: Climate Program, and DEI Program, support emergency response PIO, develop and maintain communications resources on Intranet, secondary web support for TC Home and BoCC external webpages, support Assistant County Manager #2, and social media manager – secondary.

Creative Content: Without the extension of the contract with TCMedia as the designated service provider for audio/visual needs, the county must hire an internal staff person to create content for the county and post to the Comcast channels through coordinate with Olympia, Lacey, and Tumwater (using CASTUS system). Duties would include creative content specialist, own the BoCC production room, serve as director/editor for all media production, work with Comcast/CASTUS and cities for posting on channel, work with internal staff to create more opportunities for video and photo content creation, social media content development/support, manage county YouTube channel, and develop training program for staff/other content developers.

How will this change the performance of your office or department?

Statement of Need

The addition of two public information specialists will allow the county to provide the most efficient, sustainable, and fiscally responsible option for meeting and expanding the audio/visual production and public information needs for Thurston County government serving both internal and external customers.

Expenditure, FTE and revenue assumptions plus current budget level

Assumptions

- Two, full-time Public Information Specialist total cost \$229,774 (mid-range of salary, benefits, etc.)
- Annual cost of TCMedia contract: Contract includes increase in funding based on the CPI for the prior year. This is General Fund money contributed through the Comcast Franchise agreement based on connections to customers * 2023: \$330,692 (9.0% increase from 2022)
 - *2024: \$341,755.79 (5.0 % CPI estimate Économic and Revenue
- Work with Olympia, Lacey, and Tumwater to share cost for access to channel and coordinate posting. (Approximately \$45,000 annually split amongst the participating jurisdictions)
- Would return approximately \$97,000 to the general fund

Current Budget Level

\$341,755.79 in 2024 of general fund to the TCMedia contract
