Statement of Need

Add one Assistant Court Administrator, three Judicial Assistants and one Family Court Facilitator -

County population growth and changes to state law have put new pressures on the Court. The Court's caseload is growing in many areas while also becoming more complex. The Court has a duty to provide timely administration of justice. The constitutional right of access to the courts is impaired when case resolutions are delayed. This package identifies positions that will allow the Court to meet this duty for our current caseload and help us to meet this duty in the future. It also supports the Superior Court's mission which is to serve the public through the prompt resolution of civil and criminal cases in a manner that ensures access and fair treatment.

Add an Assistant Court Administrator - this position will support the Superior Court Administrator, our nine elected Judges, and all staff in meeting obligations of the Court. The position will assist with the administrative and management functions of the Superior Court by providing leadership and support of the Court's executive functions, including strategic planning, systems development, support and implementation, and policy development.

Add three Judicial Assistants - Without these positions, the judicial officers do not have sufficient support to manage their courtrooms and caseloads. With the addition of these three permanent positions, our ratio of judicial assistant staff to judicial officers will be 10 staff to 12.2 judicial officers. While not fully achieving a 1:1 ratio for all the Court's judicial officers, it will move us in the direction of achieving an appropriate support to judicial officer ratio. This step will allow us to provide a 1:1 ratio for our nine elected judges.

Add one Family Court Facilitator - This position supports compliance with our local rule that requires review of final orders by a legal professional before presentation to the Court. This position will allow Family and Juvenile Court to operate in a more streamlined fashion by helping self-represented parties and their cases progress through the court system more quickly and minimize parties having to return to Court multiple times because forms are not completed correctly or because proposed orders have not been prepared. Often self-represented parties do not know how and cannot afford to hire an attorney to prepare final orders on their behalf. The court facilitator will support achieving case resolution timelines, reduce calendar congestion, and improve access to justice for self-represented parties.
