Statement of Need

District Court is requesting the Administrative Assistant position for Mental Health and Veterans Court (MHVC) be increased from $0.75\ FTE$ to $1.0\ FTE$.

In 2022, the Board approved TST funding to support the addition of our 3rd Care Coordinator position, effective January 2023. MHVC has maintained a full caseload of participants and continues to effectively serve each participant through progressive best practices to address needs through wrap-around services and ongoing support.

How will this change the performance of your office or department?

Statement of Need

Increasing the Administrative Assistant position to 1.0 FTE will allow for efficient support of all Care Coordinators and a full caseload of MHVC participants. Extending wrap-around services and continued development of best practices requires an increase support from this position to continue to meet program goals and objectives.
