Statement of Need

District Court has limited funding to address needs associated with training and conferences for staff and judges. The current budget is limited and prevents the court from providing necessary access to resources that can better each individual as an employee, as well as the service to the public that the court provides. District Court serves all members of Thurston County, to include those that may have resource barriers, mental health or substance abuse issues, and additional access needs. Training expenses support the ability of the court to look at continued education that can provide a better resource to the public seeking resources from the court in a positive, progressive, and effective manner. In addition to the above, District Court continues to have a progressive approach on best practices and means to supporting our communities. Conferences and education provide the opportunity for management, judges, and staff to bring back important and progressive training that will allow us to be proactive in adjusting business practices to providing a great service to our communities.
