Statement of Need

District Court is requesting that funding to support small tools and minor equipment for Mental Health and Veterans Court (MHVC) be increased by \$3,000. Current allocation allows for minimal support to address needs for staff. There is no funding available that allows for the replacement of failed hardware or modernizing services to support participants within the program.

How will this change the performance of your office or department?

Statement of Need

Increasing the allocation to support equipment for MHVC will allow District Court and the MHVC program to support program participants through modern services. Items of consideration can include secured accounts compliant with client/information protection requirements to prepare and share documents identified by justice and funding partners; a computer station allowing for Care Coordinators to assist with job or housing searches and applications; privacy sound machines for private Coordinator-Participant meetings; and, supporting equipment needs for Monday Meetings which allows for participants to gather and support each other through non-judicial activities.

This allocation is also used for replacement of any needed or failed hardware. The current allocation does not provide for adequate funding to support a failed item, such as a copier or computer that is not within warranty.
