## What do you need and why? Include any unexpected and external requirements.

#### Statement of Need

Two Prosecution Investigator positions need to be created to assist with the Criminal Division caseload. The PAO currently has no investigative resources and relies exclusively on law enforcement to conduct investigative follow up and to locate witnesses. Law enforcement follow-up has declined due to their staffing, workloads, and growing demands on their resources. Adding investigators to the Prosecutor's staff would greatly benefit the deputy prosecutors in providing investigation services. Creating two investigator positions was explored in the 2022-23 budget to be funded by ARPA and the PAO has been working with HR to finalize the creation of these positions. The investigator's primary focus will be the Criminal Division's backlog of cases which allows their time to be charged to the ARPA project through December 2024. The PAO is requesting that these investigator positions continue beyond December 2024.

#### How will this change the performance of your office or department?

Statement of Need

Having Investigators on staff will expedite the review of referrals and the filing of cases, meet urgent investigative needs when preparing cases for hearings and trials, and reduce the burden on law enforcement to provide follow-up investigations.

#### Expenditure, FTE and revenue assumptions plus current budget level

#### Assumptions

Prosecutor's Investigator, \$106,000 for salary and benefits. Two Investigators will be \$212,000 per year for salaries and benefits.

The investigator's primary focus will be the Criminal Division's backlog of cases which allows their time to be charged to the ARPA project through December 2024. The Prosecutor's office is requesting to continue these positions when the ARPA funding ends.

#### Current Budget Level

There is currently no budget for these two positions in the 2024-25 personnel budget. However, two positions were requested for the ARPA project but were not approved or funded until HR and the PAO completed review of the job specification for this position and set the salary. It is estimated that each position will be approximately \$106,000 per year for salary and benefits.

## What happens if this isn't funded? Are there other options?

Impacts and Alternatives

The Prosecutor's Office will be asking law enforcement to conduct supplemental investigations. Because law enforcement is short staffed, cases will be delayed waiting for their response. Alternatively, the deputy prosecutors will use their time to conduct additional investigations, increasing the workload and delaying resolutions to the cases.
