What do you need and why? Include any unexpected and external requirements.

Statement of Need

The Victim Advocacy positions are funded by penalty and assessments and two grants. There is insufficient revenue to support all positions assigned to the Victim's Fund. Since COVID, there has been a significant change in the collection of penalties and assessments, to include a change in the way Superior Court orders assessments. The legislature stepped in last session and came up with HB 1169 that eventually will fund the Victim's Fund \$250,000 per year. Unfortunately, the legislature made a mistake and only 50% will be awarded until the amount is corrected in the 2024 session. Until the revenue is stabilized, it is proposed that two positions are moved to the General Fund to be filled as budget is available or vacant until funds are stabilized. Advocacy is critical with the Criminal Division caseloads and the PAO does not have sufficient revenue in the Victim's Fund. In addition, the Victim's Fund previously received a grant for \$73,575 that ended in December 2021 and the CVAN grant was reduced by \$70,545. These two reductions alone would have funded two victim advocates. Also, in 2019 the PAO received \$371,961 in penalties and assessments due in part to the collection efforts of the Clerk's Office. Combined, the Victim's Fund has experienced a reduction in revenue of \$266,081 since 2020.

How will this change the performance of your office or department?

Statement of Need

Victim Advocates will be available to provide services to the victims of crime who would otherwise be assisted by Paralegals, Legal Assistants and the Deputy Prosecuting attorneys. This is an example of reallocating the duties to staff who are in positions experienced and trained for the services needed creating internal efficiencies.

Expenditure, FTE and revenue assumptions plus current budget level

Assumptions

Victims Fund is projected to receive revenue of \$558,961 in 2024. Salaries and benefits for current Victim Advocate positions is \$705,255 for 2024. Two positions will remain vacant to maintain a reserve in the Victim's Fund to meet cash flow needs and cover operating expenses for 2 to 3 months.

Current Budget Level

Victim's Fund Revenue is: \$569,597 Victim's Fund Expense is: \$821,413 Estimated fund balance: \$240,639

Reducing the budget in the Victim's Fund by reallocating two Victim Advocate positions from the Victim's Fund to the General Fund will keep the fund from going over budget.

What happens if this isn't funded? Are there other options?

Impacts and Alternatives

Eliminate the positions and reduce services to victims of crime. Reallocate the Victim Advocate positions to the General Fund and keep them vacant until revenues stabilize or the BOCC authorizes budget for Victim Advocacy positions in the general fund.
