Statement of Need

The PAO needs Deputy Prosecuting Attorney positions to be increased to keep up with the high demands of a growing caseload. There are an increased number of homicides and other violent crimes that take an extensive amount of time to review and process and take to trial. The current number of Deputy Prosecuting Attorneys cannot continue to process the increased workload without getting some relief. Over the last two years, the PAO has received multiple resignations due the increased workload and insufficient compensation for the prosecution of cases in the Criminal Division. Without adding deputies and compensating the deputies sufficiently for the expertise, the PAO will be insufficiently staffed and community safety will be impacted.

How will this change the performance of your office or department?

Caseloads will be processed in a timely manner and the community will be safer.

Assumptions

Based upon initial calculations, the PAO will be saving the county over \$500,000 due to hiring staff with less experience than those who left the PAO. The PAO respectfully requests that this significant change in personnel costs from the 22-23 budget comparied to 24-25 be considered as their general fund reduction proposal.
