Statement of Need

Funding is requested to replace 26 Automated External Defibrillators that are at the end of their useful life. Earlier this year, Medic One procured 50 Automated External Defibrillators for Sheriff's Office staff to carry in patrol vehicles. The Sheriff's Office needs 26 more Automated External Defibrillators to complete replacement of its Automated External Defibrillators that are at the end of their useful life.

Often, law enforcement is the first unit on scene. When an individual is in cardiac arrest, time is of the essence and accessibility to an Automated External Defibrillator may determine whether the individual is revived or not. The Centers for Disease Control reference a study by Gilchrist, et al. (2010) where the authors state that, on average, 8% of those who experience an out of hospital cardiac arrest will survive to hospital discharge. This percentage increases as a person who experiences cardiac arrest is 2 to 3 times more likely to survive if an automated external defibrillator is used before emergency medical services arrives.

Please note that we researched a lease option for these Automated External Defibrillators and found that purchasing was more cost effective.

How will this change the performance of your office or department?

Statement of Need

Funding this request will allow us to have an operational Automated External Defibrillator in each patrol vehicle.

Assumptions

Cost per Automated External Defibrillator is \$2,400 + tax: 26 X \$2,400 X 1.095 (9.5% sales tax) = \$68,328.

Current Budget Level

The current law enforcement General Fund budget amount is \$26,315,773.

What happens if this isn't funded? Are there other options?

Impacts and Alternatives

Requesting this funding is the only option. If this request is not funded, then we will have 26 patrol vehicles without an Automated External Defibrillator in the vehicle. This may impact the survivability of those that may be in cardiac arrest as law enforcement is often the first on scene.
