Statement of Need

Based on FY 2019 through FY 2022 expenditure trends and the FY 2023 forecasted end of fiscal year balance, TCPD forecasts an conservative ending balance of approximately \$431,000 for FY 2024 and FY 2025 (approximately 5.2% of budget authority). TCPD wishes to maintain a 2% budget balance (authority) per fiscal year as reserve (approximately \$175,000) and adjust the forecasted ending balance to \$256,000 per fiscal year.

Thurston County Board of County Commissioners will determine how to apply the \$256,000 reduction to one or more of the new positions requested by Thurston County Public Defense.
