Statement of Need

CPED has a small fiscal team consisting of a fiscal manager and a fiscal analyst in support of almost 70 employees and multiple funds/divisions. An Accounting Assistant IV would allow the fiscal team to utilize more advanced technical accounting, fiscal, and budget support. The Account Assistant IV will have involvement in all of CPED's budgets including, but not limited to: preparing complex financial plans, multi-fund budget development, grant, and contract management and billing. The person filling this role will be tracking cash receipts, disbursements, and classifying proper accounts in accordance with BARS and county procedures. Additionally, the role would be responsible for developing and implementing great systems for internal controls as well as checks and balances.

How will this change the performance of your office or department?

Statement of Need

The new position would assist in technical level grant financial monitoring, maintaining fund health & oversight, financial planning and forecasting, assist in the budget development process, posting complex financial data to general ledgers, tracking cash receipts & disbursements, interfund billing and JEs, etc. The Accounting Assistant IV position would serve as a backup to the fiscal analyst and manager within CPED. Additionally, the Accounting Assistant IV's purpose would be to offer multi-fund and division budget monitoring, project revenue availability, budget trends, and County budget (as well as SAO) compliance requirements. This position would attend budgetary meetings with the budget office as well as upper management in the development and support of CPED's multiple budgets.
