# Statement of Need

Water and Sewer Utilities is requesting \$4.85M for the Grand Mound Wastewater Treatment Plant (WWTP) Phase 1 Improvement Project (CP #94524). This request includes a \$779K reallocation of Real Estate Excise Tax 2 (REET2) funds from the Grand Mound Second Oxidation Ditch Project (Ref B-34-025) and a \$1.5M reallocation of REET2 funds from the Grand Mound Wastewater Treatment Plant Expansion for Class A Reclamation (Ref B-34-120). The WWTP project was identified during the Grand Mound facility planning effort and will make improvements to the oxidation ditch, solids handling equipment, and UV disinfection system at the Grand Mound wastewater treatment plant. These improvements will ensure that the plant can serve projected growth in the UGA and meet its discharge permit requirements. This project will allow construction of the Grand Mound Second Oxidation Ditch (CP #94521) to be postponed (Ref B-34-025).

#### How will this change the performance of your office or department?

Statement of Need

The Grand Mound WWTP must be upgraded in order to serve growth expected within the Grand Mound UGA, and to achieve compliance with NPDES Permit No. WA0042099 for continued service to the community.
