Statement of Need

The Roads & Transportation division is requesting an additional \$2,110,849 for the Tilley Rd S - Old Hwy 99 SW to Goddard Road SW project (CP #61317), for a total revised project cost of approx. \$4.094M. This project has received \$2.1M from Rural Arterial Program (RAP) grant funds, \$1.079M in Surface Transportation Block Grant (STBG) funds, \$201K Transportation Impact Fees, with the remaining from County Road Fund. The RAP award provided additional funding to extend the project limits for the safety and preservation improvements on this project.

This project will construct improvements at the intersection of Old Hwy 99 and Tilley Rd to widen and reconstruct the roadway to provide additional turn lanes, illumination and drainage and enhanced driver safety on 0.90 miles of Tilley Rd to Goddard Rd SW. This is a high accident location that has resulted in 8 serious injury accidents in the last few years due to unprotected turning movements.

This request includes grant funding awarded and shifts in previously recognized revenue and expenditure authority between project years to align with the Capital Improvement Program. Specifically, this request adds STBG grant money of \$1.079M and an additional \$918,750 in RAP funding based on the final grant amount awarded.

#### How will this change the performance of your office or department?

Statement of Need

This project will enhance driver safety at the intersection of Old Hwy 99 and Tilley Rd by providing a separation between turning vehicles and through traffic, improve capacity and mobility, and address asset preservation needs within the project location.
