Statement of Need

The Roads & Transportation division is requesting \$160K for the Old Pacific Hwy and Kuhlman Intersection project (CP #61553). This funding, provided by \$150K Transportation Impact Fees and \$10K County Road Fund, will be used to complete the predesign and design phases for this project.

Old Pacific Hwy is a popular route to access I-5 for the Yelm, Rainier and Lacey communities, and traffic volumes continue to increase as development grows in those areas. Traffic congestion has exceeded the accepted level of service C as identified in the County's Comprehensive Plan. 10 collisions have occurred at this intersection in the past 5 years. Several alternatives are being considered for this project including a roundabout, traffic signal, and pedestrian safety enhancements.
