Statement of Need

The Roads and Transportation division is requesting \$465K in Transportation Impact Fee (TIF) funding for the Old Hwy 99 at Intersections of Sargent Rd and 201st Ave project (CP #61548). There is no change to the total approved project funding of \$3.890M. Use of TIF funds, addressing capacity elements of the project, will reduce the amount of County Road Fund expended on this project, which is funded by a combination of federal grant dollars, TIF and County Road Fund, and staff will continue to seek additional grant funding for this project. These funds will be used to complete the design and construction of the Old Hwy 99 at 201st and Sargent Rd Intersection project.

This project will construct a roundabout and channelization on Old Hwy 99 at 201st and a right-in right-out intersection treatment at the intersection of Old Hwy 99 and Sargent Rd. With the increase in traffic due to development and the new roundabout at Sargent Rd and US12, this is a necessary safety improvement.

How will this change the performance of your office or department?

Statement of Need

This project will improve safety. The project will construct a roundabout and channelization on Old Hwy 99 at 201st and Sargent Rd combined intersections. With the increase in traffic due to development and the new roundabout at Sargent Rd and US 12.
