Statement of Need

The Roads and Transportation division is requesting \$11M this biennium (\$5M in 2024 and \$6M in 2025) for the Pavement Preservation Program (CP #98225), funded by \$1M in Real Estate Excise Tax (REET2) funding and County Road Fund. The planned program consists of a \$5M 2024 Chip Seal program and a \$6M 2025 Overlay program. This program provides for a more robust preservation program to address the continued deterioration of roadway infrastructure and increased maintenance costs due to growing infrastructure to address growth. Increased resources directed toward these efforts will allow for a more comprehensive and effective program and allow the county to capitalize on contract efficiencies and advantageous pricing. The REET2 funding, invested in overlay projects, is a continuation of foundational funding (\$2M per biennium) provided by the Board of County Commissioners for the preservation of our transportation system, in recognition of the increased expanse and use of our road network. An additional \$1M was approved by the Board previously to support two specific overlay projects in 2024: Pacific Avenue Pavement Preservation (CP #98408) and Yelm Highway Pavement Preservation (CP #98409).

Investment in road preservation activities extends the life of road sections 10-20 years, protecting the integrity of county assets and reducing the need for future major construction costs. Roadway preservation techniques and minor rehabilitation continuously maintain road surface conditions in compliance with WAC 136-70-010.

How will this change the performance of your office or department?

Statement of Need

This project will extend the life of the road system by replacing culverts (that may be more than 50 years old) with new structures. This project will benefit the community by improving conditions for fish to spawn, rear, and live in our local waters. This may also reduce maintenance costs, but projecting actual costs is speculative.
