Statement of Need

The Roads and Transportation division is requesting \$100K this biennium (\$50K each year) for the Americans with Disabilities Act (ADA) Improvements Program. This program is funded by the County Road Fund. Projects in this program seek to improve access to the county's transportation system for people with disabilities. Federal mandate requires that individuals with disabilities are provided equal access opportunities. Projects to address this mandate include engineering, survey, right of way acquisition, and construction of ADA improvements.

These projects will improve bicyclist and pedestrian safety and address federal mandates for ADA compliance.
