Statement of Need

The Parks & Trails program is requesting \$50K this biennium (\$25K each year) for the Parks & Trails Improvements and Development Program (CP #51096), to be funded with \$15K of Parks Impact Fees and \$35K of Real Estate Excise Tax 2 (REET2) funding. This program provides funding for capital and major maintenance projects required on the Parks & Trails assets, such as facilities upgrades and repair. Through this funding, the Parks & Trails program is able to respond to emerging or unexpected needs of our assets and infrastructure, many of which have exceeded their life expectancies, in order to keep our facilities safe and accessible for public recreation use.

This program is funded through Parks Impact Fees (30%) and Real Estate Excise Tax 2 funds (70%).

How will this change the performance of your office or department?

Statement of Need

This funding enables us to maintain our current level of service and respond to emerging safety and repair needs, particularly as user volume increases over time on our parks and trail assets.
