Statement of Need

The Parks & Trails program is requesting \$50K this biennium (\$25K each year) for the Parks, Trails and Open Space Acquisition Program (CP #51095), to be funded by \$30K in Parks Impacts Fees and \$20K in Conservation Futures (CF) funding. This request continues the ongoing allocation of Conservation Futures funding for the Parks & Trails Acquisition Program, to partially fund future potential parks and trails related acquisitions. Using Conservation Futures funding for acquisitions is a strategic investment that allows for the use of CF funding for ongoing maintenance and operations costs of properties acquired with an initial CF investment.

The Thurston County Comprehensive Parks, Open Space, and Trails (POST) Plan defines the need for additional public recreation areas and open space to accommodate for growth in the county. The Acquisition Program was established to assist the County in maintaining compliance with the Thurston County Level of Service standard in terms of acreage (3.0 acres per 1,000 residents as established in the Board approved POST Plan). Additionally, this program allows for the potential purchase of properties that may become available in the future, providing agility to address any time constraints associated with purchases.

How will this change the performance of your office or department?

Statement of Need

Our trails are heavily-utilized assets of the community. Taking community input and proper stewardship responsibilities into consideration, Thurston County has determined a Level of Service (LOS) standard of 3.0 developed acres per 1,000 residents and a per capita LOS as described in the 2020 Park Impact Fee Study. Based on the projected 2040 population data & LOS standard, an additional 210 acres of developed parkland are needed by 2040 to meet the target LOS.

Assumptions

The cost of property acquisitions varies considerably based on size, location, market, etc. This funding provides a basis for action should property meeting the criteria above be identified and become available.
