The Stormwater Utility is requesting \$200K in 2024 to complete a study on Abernathy Street. Stormwater engineering is observing increased development activity on Abernathy Street, which is an area known to have high groundwater and overwhelmed conveyance facilities. This case study would evaluate root causes of localized flooding issues to inform Drainage Manual policy decisions. This study differs from a capital project predesign study as it will inform policy development, enforcement and implementation practices.
