#### What do you need and why? Include any unexpected and external requirements.

Statement of Need

The Solid Waste division has an immediate need for an additional full-time Building and Grounds Maintenance Specialist litter control staff member. The Community Litter Cleanup program used to be supported by additional seasonal staff and labor resources (i.e., corrections and inmate crews) that are now only infrequently available. At the same time, data shows that community litter continues to increase in Thurston County (see data below). The purpose of this position is to improve our litter control activities in Thurston County through an additional dedicated staffing resource. We currently only have one full-time regular employee working in this program. This position would provide us an opportunity to be more proactive in our litter control activities and to meet program objectives, such as improving our litter control efforts on county roads and increasing our response time to incidents of illegal dumping. This would also help provide the additional staffing needed to implement a new "Adopt-a-Road/Park" program, which would leverage community volunteers to assist in litter cleanup efforts. In addition to increasing the program impact, because the litter crew staff would be able to work in tandem, the safety of staff would improve by limiting strain or injury when lifting heavy items. The cost of this additional staff is approximately \$97K, a portion of which would be funded through annual grant funding received from the Department of Ecology for the Community Litter Cleanup program.
