Statement of Need

Public Works is requesting 2 Education and Outreach Specialist positions to support the work of the Solid Waste division and the department. The Education and Outreach II (E&OII) position will focus on youth education programs. With current staffing levels and staff transitions, we are not actively engaged in youth programs. Implementing a consistent, practical youth education and outreach strategy requires the dedication of a full-time position. This position is essential for fulfilling the educational requirements stipulated in our Solid Waste Management Plan. To provide context for potential reach, in the 2022-2023 school year, 6,288 students are enrolled in 4th and 5th grades across 47 schools in Thurston County. The responsibilities of this position extend beyond designing curricula and teaching, to include providing training and support for educators, managing educational resources, and continuously evaluating and refining the program based on feedback and best practices. This dedicated role is also critical for building stronger connections with local educators and institutions, ensuring a more comprehensive understanding of our waste reduction strategies.

An Education and Outreach Specialist I (E&OI) position is requested to assist in the implementation of department education and communication programs. With an increasing Thurston County population (>300K), expectations for continued growth (29.7% increase by 2040), and continued regional and state emphasis on reducing our solid waste environmental blueprint through incentive programs, legislative and regulatory actions, additional resources are needed to support effective education and outreach communication programs. Duties assigned to this position will significantly support the development and implementation of the following Solid Waste Reduction and Diversion programs identified in the Solid Waste Management Plan and in response to recent legislation:

- Residential/Multi-Family
- Commercial
- Youth
- In-House/Gov't
- Litter
- Compost/Organics (HB 1799)

Working in collaboration with an existing Education and Outreach I position, this position will provide support to 3 Education and Outreach Specialist II positions and the Communications and Outreach Supervisor to achieve Solid Waste and broader Public Works communication program goals. This position will manage the flow of information by providing assistance with the development of materials and publications; gathering of materials for presentations, field-based public contacts and events; and data gathering and tracking of education and communication activities to capture audience reached, message delivery and impact. In addition, this position will maintain our online presence across multiple platforms, update outreach materials, and manage the new customer feedback mechanisms outlined in the Public Works Strategic Plan.

The estimated 2024 cost of these positions is \$104K and \$112K respectively.

Statement of Need

The E&OII position will provide a staffing mechanism for developing and reaching Thurston County youth through education programs and working toward the achievement of youth education goals outlined in the Solid Waste Management Plan.

The E&OI position will provide foundational support for the suite of Solid Waste programs identified in the Solid Waste Management Plan including multi-family and commercial outreach, food reduction and diversion education, compost and organics education required by new legislation and litter control/clean-up initiatives.
