Statement of Need

The Parks and Trails program is proposing adjustments to the Conservation Futures budget to utilize the maximum amount of funding available for maintenance and operations on eligible parks and trails. The estimated maximum amount of available funding is approximately \$386K and \$394K for 2024 and 2025. Proposed amounts are based on an estimated 2% annual increase in revenue growth. This request adjusts the maintenance level budgets carried forward from the prior year to the new available funding amount.

25% of Conservation Futures funding may be used to support eligible Parks and Trails M&O expenses and is a critical revenue source to the Parks & Trails program. The annual rate increase allows for the Parks & Trails program to keep pace with inflationary factors and to provide for continued level of service benefits to residents and users of our parks and trails system.

How will this change the performance of your office or department?

Statement of Need

Increased funding for Conservation Futures Parks and Trails is proposed in 2023 and 2024 to account for inflationary costs and maintain the current level of service.

Assumptions

The estimated available funding for maintenance and operations is based on 2022 actual Conservation Futures revenue received, adjusted for 2% increase each year. 25% of that total is provided for Parks & Trails maintenance and operations. See attached worksheet.

This request also includes operating transfers to account for the overhead costs charged to Conservation Futures eligible parks and trails based on indirect costs incurred in the General Fund.
