Statement of Need

Thurston County has been awarded \$700,000 for the 2025 Comprehensive Plan Periodic Update by the Washington State Department of Commerce. The allocation was determined with a formula using population size. Due to the way funding is appropriated by the legislature, one-half of this funding is available July 1, 2023 to June 30, 2024 and one-half is available July 1, 2024 to June 30, 2025.

CPED is also requesting an additional \$210,000 for additional profession services necessary to complete the Comprehensive Plan Periodic Update.

This funding would support the acquisition of expertise for the 2025 Periodic Comprehensive Plan Update, Thurston 2045. The expertise will assist the county in its decision-making process and environmental review.
