Statement of Need

As directed by the Board, the Community Planning Division will need additional staff to speed up existing docket amendments, staff new amendments for the 2024-25 dockets, and to work on the Comprehensive Plan. The periodic update to Thurston County's Comprehensive Plan, associated joint plans with the cities and necessary Assistant Planners will be assigned lower-level work while Associate Planners will be assigned journey level work.

How will this change the performance of your office or department?

Statement of Need

Provides enhanced customer service to residents in Thurston County and will help expedite remaining and new docket amendments. Long range work plans and workloads are set annually by the Board of County Commissioners through the annual docketing process. Once a docket is approved, the workload is distributed to Community Planning staff.

The Assistant Planner position will assist higher level planners on their projects to free up their time for higher level work. The position will also be assigned lower-level development code amendments and comprehensive plan work and will conduct technical research studies and prepare statistical reports and recommendations for a variety of planning projects including drafting or revising local legislation and plans, projecting trends, monitoring socioeconomic changes or informing the public.

The Associate Planner position will be assigned development code and comprehensive plan projects. The person in the position will need to conduct independent technical research studies and prepare statistical reports and recommendations for a variety of planning projects including drafting or revising local legislation and plans, projecting trends, monitoring socioeconomic changes or informing the public.
