Statement of Need

This position will be responsible for the development, management, and coordination a wide range of initiatives on behalf of Thurston County including administration of county-wide initiatives on behalf of the Board of County Commissioners. Responsibilities will include development of long- and short-range agricultural program goals, developing budgets, serve as staff to assigned agriculturally related boards and commissions and working with regional stakeholders at the local, state, federal and tribal level.

How will this change the performance of your office or department?

Statement of Need

This reclassification will:

*help farmers and prospective farmers navigate Thurston County code requirements and permitting processes unique to agricultural land uses and activities, including permitting for conservation projects;

*support implementation of Voluntary Stewardship Program and other agricultural programs;

*conduct outreach around Thurston County with incentive programs designed to support farmers and farmland (e.g., open space tax program, conservation futures, transfer of development rights);

*help connect farmers and agricultural landowners to County partner organizations doing conservation, technical assistance, and economic development (e.g., EDC, WSU-Extension, Thurston Conservation District, local farmland trusts);

*support the implementation of agriculture goals, objectives and policies in the Thurston County Comprehensive Plan; provide input to code updates specific to issues faced by the agriculture community; conduct internal staff trainings on emerging issues related to agriculture and local planning; and

*act as a liaison from the County to community partners and organizations on County permitting and development issues affecting local agriculture.
