# What do you need and why? Include any unexpected and external requirements.

Statement of Need

Pretrial Services is requesting 1.0 FTE Administrative Assistant II to provide support and structure to the department and allow staff to focus on core pretrial services functions. Currently this department has no administrative or general support, and basic administrative functions take staff away from managing caseloads and providing information to the Court. Cost will be split between GF and TST.

# How will this change the performance of your office or department?

Statement of Need

This position will free up time for core pretrial duties for current staff, ensure compliance with County policies and expectations, and increase the department's ability to use and report data.

#### Expenditure, FTE and revenue assumptions plus current budget level

Assumptions

Request includes FTE costs (salaries, benefits) as well as supplies, equipment, travel and training expenses.

Cost allocation to be split across GF and TST based on the number of positions this new FTE would support. Currently, Pretrial Services has 11 FTEs; 7 are funded through GF and 4 are funded through TST. This request assumes that 4/11 of the cost of the position would be charged to TST and 7/11 would be charged to GF.

Current Budget Level

Current GF budget is \$1,007,855 (\$860,301 salaries/benefits).

Current TST budget is \$542,843 (476,619 salaries/benefits)

#### What happens if this isn't funded? Are there other options?

Impacts and Alternatives

If this request is not funded, department leadership and skilled pretrial staff will continue to manage all administrative and support tasks. This is inefficient, leads to inconsistency and certain tasks not being completed, and takes away from skilled pretrial staff's ability to manage caseloads and develop program improvements.
