Statement of Need

Pretrial Services is requesting 1.0 FTE Operations Assistant (underlying classification is Victim Advocate) for the Thurston County Resource Hub. This is a TST request. This position is needed to allow for more individualized attention for visitors, enable expanded Hub hours, and strengthen safety protocols.

How will this change the performance of your office or department?

Statement of Need

An additional FTE working in the Resource Hub will allow for more individualized attention for visitors, enable expanded Hub hours, and strengthen safety protocols. Currently only 1 staff person is allocated to run all aspects of the Resource Hub, and it is challenging for one person to manage day-to-day operations, develop and maintain partnerships, participate in County meetings, and find coverage for planned and unplanned leave.

Current Budget Level

Current TST Resource Hub budget is \$144,149 (\$129,962 salary/benefits); this change would increase the Hub team from 1 to 2 staff people.

Impacts and Alternatives

If this request is not funded, the ability to expand the hours or the space of the Hub will be constrained. Safety protocols will be limited. Operations of the Hub during the Program Manager's vacations, sick days, or meeting times will continue to be limited to TST-funded Diversion Officers who have different skills and background than is needed for the Hub and are taken away from their caseload duties in order to provide this coverage.
