#### What do you need and why? Include any unexpected and external requirements.

Statement of Need

Pretrial Services is requesting 1.0 FTE Pretrial Services Officer I for the Diversion Unit. This is a TST request.

Additional capacity in the diversion unit will allow services to 50 more clients at any given time, including those referred for diversion due to drug possession charges under SB 5536 as well as individuals referred as the COVID backlog is processed.

## How will this change the performance of your office or department?

Statement of Need

This will allow Pretrial Services to provide Diversion Services to an additional 50 or more defendants with substance use disorder and/ or mental health needs at any given time. Diversion emphasizes a connection to behavioral health treatment, and successful completion of a diversion agreement results in dismissal of or reduction in charges.

## Expenditure, FTE and revenue assumptions plus current budget level

Assumptions

Request includes FTE costs (salaries, benefits) as well as supplies, equipment, travel and training expenses.

Current Budget Level

Current TST Diversion budget is \$398,694 (\$346,657 salaries/benefits); this change would increase the diversion unit from 3 to 4 Pretrial Services Officers.

## What happens if this isn't funded? Are there other options?

Impacts and Alternatives

If this request is not funded, it may be necessary to create waiting lists for defendants who are otherwise eligible for diversion. If these cases move through the criminal justice system in a more traditional manner, they may not get the help needed to address their behavioral health needs and are likely to be more costly to the overall law and justice system.
