Statement of Need

In 2023 Public Health & Social Services (PHSS) and Public Works (PW) worked together to develop an updated Memorandum of Understanding (MOU) between our two departments. This MOU details the roles and responsibilities of PHSS to fulfill statutory requirements in state and county code, implement the Thurston County solid and hazardous waste plans, and perform certain solid waste abatement activities; PW's roles and responsibilities to assist in fulfillment of these activities; and the process for allocating adequate tipping fee funding to achieve these objectives, to the extent not covered by other funding sources and as permitted by state law. This request details the direct allocation of funds from tipping fess as outlined above.

How will this change the performance of your office or department?

Statement of Need

This request for direct allocation of funds will allow PHSS - Environmental Health to meet Washington State law and Thurston County code requirements to conduct or oversee many solid and hazardous waste activities that have been assigned to PHSS by the Board of County Commissioners (BoCC) through the Thurston County Hazardous Waste Management Plan and certain provisions of the Thurston County Solid Waste Management Plan. This direct allocation allows staffing levels to consistently be at minimum levels to meet these mandated services. This is a change as staffing levels were previously based on state funding which can change. This establishes a set standard of staffing level.

Assumptions

This direct allocation will ensure budget authority for required staffing levels, but it is assumed and agreed upon by both departs that PHSS will continue to maximize available grant opportunities and funding to reduce tipping fees required for activities covered by the MOU.

Impacts and Alternatives

If this isn't funded, we would need to adjust the agreed upon MOU and return to the current process for use of tipping fees to fund positions which is by submitting invoices quarterly to PW, and PW prepares journal entries to reimburse PHSS for costs incurred for the mandated services provided and required grant matches for various grants through the State. This process does not allow for staffing levels to be budgeted consistently as State grants and contracts change and can be decreased and increased over time.
