Statement of Need

Thurston County Treatment Sales Tax currently funds Housing Case Management (HCM) services to support stabilization and recovery of individuals with a mental health and/or substance use disorder diagnoses. Funding provides temporary rent subsidies, transportation assistance, and housing-focused case management services to clients involved with TST-funded or other behavioral health services, including those who have recently exited or are in the process of exiting institutions. This budget request is to increase the amount of rental assistance available to house individuals with the rising costs of rent in Thurston County.

How will this change the performance of your office or department?

Statement of Need

This funding request will assist approximately 13 more people in recovery in obtaining housing assistance in Thurston County.

Assumptions

Thurston-Mason Behavioral Health Administrative Service Organization (TMBH-ASO) is requesting \$20,000 to increase the amount of rental assistance provided to individuals enrolled in the Housing Case Management program.

Current Budget Level

Northwest Resources, the contracted provider, received \$382,665 for housing supports and housing case management for CY2023.

Impacts and Alternatives

Other funds are not available for the situation described in the 'Statement of Need.' If this budget request is not funded, it reduces the number of individuals who can be housed in Thurston County due to the rising cost of rent. Without stable housing, individuals are at risk of relapse and recidivism.
