Request to hire 1.0 regular full-time Office Assistant II position and to reclassify a current Administrative Assistant II position to an Administrative Supervisor.

Office Assistant duties include assisting the Administrative Services team in answering central reception phones, organizing the records room, archiving special projects, surplus inventory disposition, mail distribution, inventory tagging, spreadsheet development, and other clerical related duties. This additional employee will take these duties off of the current team and allow them to function at a higher more efficient level with the many other duties and services that Administrative Services provides.

This reclass request is inline with our request to reclassify the Administrative Assistant II position currently assigned to the Environmental Health division, currently located at the Atrium. This aligns with our goals of creating leadership capacity within our divisions.
