- ◆ if the position is vacant, or the incumbent retains the position due to no one filing (NOF 11).
- ◆ if the incumbent is serving a short (short) or unexpired (unexp) term. "Short term" refers to the period of time between certification of the general election and swearing in and only occurs when there has been a resignation. Such positions are filled by appointment until the next regularly scheduled election for that district.

Party Designations: NP - Nonpartisan, D - Democrat, R - Republican, I - Independent

Expires: This column refers to the TRUE expiration date of the term and does not necessarily reflect when the position will next appear on the ballot. In the case of an incumbent resigning and an appointment being made, the position will appear both at the next regularly scheduled election for that district, as well as at the term's true expiration.
