The Voting Center opens Jan. 14 for the February 10 Special Election. You can:

- Register to vote until 8:00 p.m. Election Day February 10
- Receive a ballot (regular, replacement, or provisional)
- Vote using the ExpressVote™\*
- Drop off your ballot

\*The ExpressVote™ is a voting assistance device that enables voters with visual impairments, cognitive/learning disabilities, or limited mobility to vote independently and with privacy.

Olympia School District No. 111 is the only jurisdiction in this local voters' pamphlet, and you will only see one measure on your ballot. Information about this measure can be found online at [ThurstonWAVotes.gov](#).

Questions regarding the measure should be directed to the jurisdiction. Feb. 2 is the last day to register to vote or update your current registration by any means (other than in person). The information must be received by an election official by this day. Ballots must be postmarked by Election Day, February 10.

Planning to mail your ballot? No postage needed! If it's a week before Election Day, use a ballot drop box!

## Introduction to the Local Measure

For each measure in the Local Voters' Pamphlet, the legislative authority of the jurisdiction placing the measure on the ballot is required to formally appoint committees to prepare statements advocating the approval and rejection of the measure. If the jurisdiction is unable to make such

appointments, the Thurston County Auditor advertises for appointments.

The Election Division encourages you to review all statements and seek additional information from the jurisdictions, the appointed citizens' committees and local media.

## Olympia School District No. 111

### Proposition No. 1

#### Technology and Capital Projects Replacement Levy

The Board of Directors of Olympia School District No. 111 adopted Resolution No. 678 concerning a replacement technology and capital projects levy. This proposition authorizes the District to continue modernizing District facilities by acquiring, developing, installing, and implementing computer technology systems, projects for operations and instruction, and other capital project expenditures to improve safety, and authorizes the following excess levies for such purposes on all taxable property within the District:

## Explanatory Statement:

Passage of this proposition would authorize Olympia School District No. 111 to continue a four-year technology and capital projects levy to continue modernizing District facilities by acquiring, developing, installing and implementing computer technology systems, projects for operations and instruction and fund other capital project expenditures to improve facilities districtwide. This proposed replacement levy is not a new tax; it would re-authorize the District's existing technology and capital projects levy, which expires in 2026.

Passage would allow the levy of \$16,703,000 for collection in 2027, the levy of \$17,676,000 for collection in 2028, the levy of \$18,707,000 for collection in 2029, and the levy of \$19,901,000 for collection in 2030 to replace an expiring levy, on all taxable property within the District. If authorized by voters, estimated levy rates per \$1,000 of assessed value would be \$0.96 (2027 collection); \$0.96 (2028 collection); \$0.96 (2029 collection); and \$0.97 (2030 collection). The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the replacement levy.
