General Rules

General Administration & Conduct

- **Authority:** General administration is vested in Fair Management. Management reserves the right to amend and enforce rules for safety and well-being. All business must be conducted through the Fair Office.
- **Standards:** Displays must be agricultural, educational, or family-oriented.
- **Behavior:** Disorderly conduct, the use of controlled substances, or being under the influence of alcohol/controlled substances is grounds for immediate removal.
- **Pet Policy:** No pets are allowed on the grounds during the Fair, except for animals on exhibit or certified service animals.
- **Smoking/Dining:** Food consumption is prohibited in barns and tack areas; meals must be eaten in designated areas.
- **Compliance:** Violation of rules after an initial warning results in forfeiture of fees/premiums and expulsion from the Fairgrounds.

II. Site Operations & Safety

- **Hours:** The Fair opens at 10:00 AM. Grounds close at 10:00 PM; all non-campers must exit by 11:00 PM.
- **Sleeping:** Overnight sleeping is prohibited except in designated camping areas or for approved animal caretakers and security staff.
- **Liability:** Thurston County and Management are not responsible for loss, damage, or injury to persons or property. Participants must indemnify the County against claims arising from their acts or omissions.
- **Obligations:** No person may incur financial obligations against Management without prior written permission.
- **Cleanliness:** All exhibitors and concessionaires must keep their premises clean at all times

III. Exhibits & Animal Care

- **Registration:** All exhibits must be registered via "Fair Entry" prior to opening day. Management may limit exhibits based on space.
- **Staging:** Livestock, poultry, and rabbits must be in place by 9:00 PM the day before the Fair. All booths must be ready by 10:00 AM on opening day.
- **Removal:** Livestock, horse, poultry and rabbits will be released Sunday night after 6pm as scheduled by the superintendents. Other exhibits may be removed at times specified in the Exhibitor's Guide under each division. Early withdrawal is prohibited except for vet-documented emergencies. Items left 14 days post-fair become County property.
- **Animal Care:** Owners must provide their own tools, hay, and grain. Animals must be fed and stalls cleaned by 10:00 AM daily.
- **Staffing:** One adult and two exhibitors per species must be present during Fair hours.
- **Control:** Animals must be under the control of a capable handler. Aggressive or unsafe animals will be removed immediately.
- **Vehicles:** Livestock trucks and trailers are prohibited from remaining on the fairgrounds or in parking lots during the Fair.

IV. Species-Specific Requirements

- **General Health:** Official fair veterinarians will conduct inspections. Animals must be in show condition and free of disease/parasites.
- **Cattle:** Must be double-tied with acceptable halters (rope preferred). No horned animals or scurs over 1 inch.
- **Sheep & Goats:** Must have USDA Scrapie identification (tags/tattoos/microchips). 4-H horned animals must have tips covered.
- **Poultry:** Requires certification of being Pullorum-Typhoid clean (within 90 days) and a Premises ID Number. Exhibitors must certify reading Exotic Newcastle Disease (END) regulations.

V. Premiums & Judging

- **Judging:** All decisions are final. Communication with judges during the process is prohibited.
- **Protests:** Must be filed in writing within 48 hours, stating the rule violation, and accompanied by a \$25.00 deposit (forfeited if the protest fails).
- **Payment:** Premiums under \$5.00 will not be paid. Checks are mailed by the County Auditor after the Fair.
- **Ribbons:** Blue (1st), Red (2nd), and White (3rd). In non-competitive classes, judges may award ribbons at their discretion.
- **New Classes:** Follow a three-year cycle: Year 1 (Exhibition), Year 2 (Ribbon only), Year 3 (Premium eligible).

VI. Concessions & Raffles

- **Contracts:** Concessions require a non-transferable contract. Solicitation or vending without a contract is strictly prohibited.
- **Operations:** Concessionaires must work within 4 feet of their booth. Advertising is limited to the interior of the booth.
- **Food Safety:** Vendors must comply with health laws and may only sell approved items. Menus and prices must be submitted 30 days prior; no price changes are allowed during the Fair.
- **Raffles:** Limited to 12 total (4 each for 4-H, FFA, and Open Class). Must be pre-approved by the Fair Board and comply with WA State Gambling Commission rules. No animal, tobacco, weapon, or alcohol prizes.

VII. Administrative Notes

- **Donations:** Services or materials donated to the Fair become property of Thurston County.
- **Accessibility:** Disabled persons requiring assistance should contact the Fair Office at (360) 786-5453.
- **Cancellations:** Concession contract cancellations must be in writing by the first business day in July to avoid fee forfeiture.

GENERAL INFORMATION AND RULES:

ENTRIES: Horticulture, Design and Special Exhibits entries will be accepted between 3 pm and 7pm on Tuesday, July 28, 2026 in the Thurston Expo Center.

Note: When entering floral exhibits in [Fair Entry](#), you will see a number immediately ahead of the title. This number refers to the National Garden Club class for tracking purposes. Please follow the class and lot numbers as outlined in [Fair Entry](#).

ADVANCED REGISTRATION is required in Divisions II, III, IV, and V by Friday, July 10, 2026 (Contact Section Consultant listed below in Schedule). EVERY EXHIBIT IN DIVISION II, III, IV AND V MUST BE ACCOMPANIED BY A LISTING OF THE NAMES OF THE PLANTS USED IN THE EXHIBIT.

CLASSIFICATION: Chairmen/Consultants in each Section shall check for conformity to the schedule.

SPECIAL ENTRY TAGS for Open Class Floral are available from the Fair Office, the Floral Department Superintendent and Black Hills District Club Presidents. A list of the Clubs and contact information for Club Presidents can be found at www.blackhillsdistrict.com/clubs. They must be completed in **pencil**. Also enter your information in the [Fair Entry](#) online system.

JUDGING: Judging will take place Wednesday, July 29, 2026 at 10:00 a.m. The General Chairman and the Classification Chairmen for each Division are available during judging for possible consultation. They, along with the judges and clerks, are the only personnel allowed on the floor during judging.

AWARDS: The Flower Show conforms to the standards established by National Garden Clubs, Inc. (NGC), page 5. The Handbook for Flower Shows (HB), 2025 edition, with revisions printed in the National Gardener Magazine (TNG) is the authority for all issues not covered by the schedule, which is the law of the show. The HB is available at local libraries and from Black Hills District Garden Club members. A list of the Clubs and contact information for Club Presidents can be found at www.blackhillsdistrict.com/club.

Stickers will indicate 1st Place, exhibit must score 90 or more (Blue), 2nd place, 85 or more (red), 3rd place, 80 or more (yellow) and Honorable Mention, 75 or more (white). The entry card with sticker may be exchanged for ribbons in the Fairground Office at the end of the fair. The decisions of the judges will be final. Any award may be withheld if the requirements are not met.

RESPONSIBILITIES: The Show Committee will take all possible care to protect exhibits but will not be responsible for loss or damage.

CONSERVATION LIST: Plants on the Washington State Conservation List may not be used in this show unless grown by the Exhibitor or obtained in a legal manner.

FRESH PLANT MATERIAL shall be emphasized in this show.

NO ARTIFICIAL "PLANT" MATERIAL is permitted in any Division.

REPLACING PLANT MATERIAL: Wilted plant material may be replaced each morning before 9:30 AM.

REMOVAL OF EXHIBITS: Exhibits may be removed Sunday, August 2, 2026 after the Fair closes, between 8 - 9 PM, and must be removed between 9 - 11 AM on Monday, August 3, 2026. Please let the Superintendent know if there will be any problem in removing an exhibit.

NON-COMPLIANCE: Those not complying with these rules forfeit all prizes.

POLICIES: The NGC exhibit policies are printed in the HB, Chapter 7, Exhibiting in the Design Division, NGC Policies and Guideline.

WIN 1ST, 2ND, 3RD AND HONORABLE MENTION RIBBONS AND BEAUTIFUL ROSETTES

Entries in Division I are eligible for WSFGC Past President Betty Belcher Horticulture Award (a rosette of green and brown,) Past President Marva Lee Peterschick Arboreal Flowering Shrub / Tree Award (a rosette of lime green,) NGC Awards including the Award of Horticulture Excellence (a rosette of green, orange and blue,) the Arboreal Award (a rosette of light and dark green,) Awards of Merit (an orange rosette,) the Growers Choice Award (a dark green rosette,) and Thurston County Fair Awards; the Lily Award, the Glad Award, the Vine Award, the Rose Award, the Gourmet Award, the Harvest Award and People’s Choice Awards.

HORTICULTURE RULES:

The Sunset Western Garden Book will be used as reference authority

1. General Requirements
 - a. All plant material **MUST** be fresh and grown by the exhibitor.
 - b. Cut annuals and biennials must have been in the Exhibitor’s possession from seeds, cuttings or immature plants for at least 90 days; perennials for at least 90 days; bulbous blooms from planting of bulb, tuber, corm, for at least 90 days.
 - c. Container-grown plants must have been in Exhibitor’s possession at least 90 days.
Exceptions: Multiple plantings and combination plantings must have been in the Exhibitor’s possession and growing together at least six weeks.
2. Entry tags are available at the Fair Office, to be filled out **in pencil** in advance. Please also enter your information in the [Fair Entry](#) online program.
3. All specimens must be correctly named by Genus, species and/or cultivar/ variety. Common name may also be given.
4. An exhibitor may enter as many exhibits as desired in any class or sub-class provided each exhibit is a different cultivar, color or type. The Committee will sub-divide classes by variety/cultivar, color or type for judging.
5. Exhibitors **must provide clear** (uncolored) glass bottles for cut specimens. Any bottle(s) not picked up by Monday, August 3 at 11 am will be discarded.
6. All specimens must be properly conditioned and groomed (cleaned). No shining agents are permitted.

7. Cut specimens should not have any foliage below water line. Wedging with plastic wrap or any other unobtrusive material is permitted.
8. Cut specimen length is not to exceed 30" except where noted.
9. Due to space limitations, containers in Section L may be no larger than 12" in diameter; Double potting is permitted.
10. Youth horticulture will be entered in Division IV Youth Exhibits, CLASS 90040: Annuals Lot 01 and 02. All horticulture rules apply.

GLOSSARY FOR HORTICULTURE

ARBOREAL: Pertaining to trees and shrubs.

BLOOM: An individual flower, usually between 1/2 and 3/4 open.

BUD: An undeveloped flower (or leaf).

CULTIVAR: A cultivated variety of a plant.

FRESH PLANT MATERIAL: Any part severed from a living plant and in good condition.

SCAPE: A bare, leafless flower stem arising from the ground. Example: daylily, daffodil.

SPIKE: A lengthened flower cluster in which flowers are practically stemless. Example: Gladiolus, snapdragon.

SPRAY: A group of florets on a branched stem, each on its own stalk.

STEM: The major supporting structure in plants to which buds, leaves and flowers are attached at regular intervals at points called nodes.

Note: Gladiolus are entered with attached leaves, preferably two for balance (leaves may be under water). The length of the stem should be in good balance to the blooms and very straight. The spike should have about one-third tight buds, one-third showing color, and one-third open blooms. Wedging with plastic wrap, Styrofoam or any other unobtrusive material is encouraged so that the spike stands as straight as possible. (Plastic wrap available from Show Committee.) The Show Committee will sub-divide Gladiolus by color before judging.

1. Entries in this Division, Sections A and B, must be pre-registered by Friday, July 10, 2026, by calling the Consultant listed with each section.
2. If after committing to an entry, a designer is unable to enter the class, it is the designer's responsibility to find a replacement and notify the Section Consultant.
3. Each design must have been created and placed by one exhibitor.
4. Only 1 entry per exhibitor is allowed in any Class.
5. A minimum of 4 exhibits is required in each class.
6. Absolutely NO artificial flowers, fruit or foliage permitted.
7. FRESH plant material may not be treated in any manner, including dye or paint. Take care with commercially available flowers – some are dyed.
8. Adult Design width is limited to 24" of table space unless otherwise stated.
9. Landscapes and/or scenes are not accepted in this Division.
10. Exhibitors are responsible for keeping their exhibits in good condition for the duration of the Fair. FREE ADMITTANCE IS ALLOWED DAILY AT 9:30 AM
11. Featured objects, accessories, container-grown plants growing in soil (where appropriate) and living plants with roots attached are permitted in all classes. Special effects are allowed where power is available.
12. Living members of the Animal Kingdom are not permitted.
13. Flags and Religious symbols, if used, must be used properly.
14. FRESH plant material is to be emphasized in this show.
15. Plant materials used in this division do not need to have been grown by the exhibitor and may be commercially grown.
16. Cut fruits or vegetables are permitted if sealed unobtrusively to discourage insects, odors and discoloration.
17. Staging panels are allowed if used within the space permitted/allowed for each class.
18. Designer is on his/her honor that the design being entered has not been previously entered or judged in an NGC Standard Flower Show.

GLOSSARY FOR DESIGN

Accessory: A subordinate object other than plant material used in a design e.g. a figurine, rock, etc.

Buffet Table: Service for four or more, with components conveniently and logically placed for ease of self service. At least one serving piece required. A decorative unit must be included. A container grown plant alone is not a decorative unit.

Creative Line Design: A creative design in which line direction is dominant, characterized by open silhouette, a minimum of plant material and other components. Dominant feature is the movement in any direction, either vertically, horizontally, diagonally, etc.

Designers Choice: Designers choice of all components.

Exhibition Table: An artistic arrangement of table components, within an allotted space, to provide a creative effect without consideration for functional placement. Plant material must be used as needed for the design.

Mass Design: A design containing a large quantity of plant material with a closed silhouette. Plant material is integrated and not grouped.

Multi-Rhythmic Design: A creative design with emphasis on two or more rhythms in the design with one rhythm dominating.

1. Lines create two or more separate and distinct rhythms, each creating different pattern and movement unlike the other.
2. Lines may go in any direction, be continuous or interrupted and or crossed.

Transparency Design: A creative design with see-through elements (translucent, diaphanous, grid-like materials etc.) integral in the design and permitting some components to be viewed through others.

Tubular Design: A creative design having dominant cylindrical forms throughout, composed of any material. Plant material and other components complete the design.

2. Artwork must have been completed within the past two years, and not previously entered in the Thurston County Fair. Plein Aire at the Fair entries must be completed on the day of registration and entirely on the fairgrounds.
3. Exhibitors are limited to three pieces of artwork each, on a first come basis, space available. "Plein-Aire at the Fair" and "Mangathon" entries are not counted in this limitation.

Thursday, Friday, and Saturday will host a "Plein-Aire at the Fair" artmaking competition. Subject matter will depict places and activities occurring specifically within the fairgrounds site. Adult Amateur and Professional/Semi-professional artists of Thurston County are eligible for this competition. Artists must register at the Art Pavilion in the morning of the day they wish to participate.

Then they must complete a 2-dimensional work of art that is at least 8"x10" during that day. The work must be returned to the Art Pavilion by the end of the day: it must be signed and dated. Any medium which can be produced entirely on the fairgrounds is permitted. Completed works do not have to be framed for this category.

Plein-Aire Artists must observe all safety guidelines regarding animals, equipment and personal and visitor safety when working on the fairgrounds. For that reason, only clear aerosol fixatives and will be permitted for plein-aire work and must be applied outdoors or in a well-ventilated area. Artists will be responsible for their materials and equipment while on the fairgrounds.

Daily awards for Plein-Aire artwork will be made by selected jurors: one 1st, 2nd, and 3rd place award will be made for all entries, regardless of amateur or professional status, each day of competition.

OPEN CLASS PRINT COMPETITION

How to Enter a Print

1. Thurston County Fair has adopted the [Fair Entry](#) online system for all entries. It is strongly recommended that you enter your prints through the [Fair Entry](#) system before delivering them to the fairgrounds and either retain a copy of the entry form on your phone or print a paper copy to facilitate our entry process at the photography exhibit. If you cannot enter online ahead of time, we will have devices available for doing so during the entry times at the fairgrounds. **When adding your item in [Fair Entry](#), please use the field "Briefly describe your entry" for the title of your photograph. Do not enter a description – just the title.**
2. You can drop off your prints from June 30 through July 22 at Beard's Framing in Lacey or Olympia FrameMaker's in West Olympia. If you do so, you **must** have registered and entered your prints through [Fair Entry](#) ahead of time and take a printed copy of your entry form to those vendors with the prints.

Prints will also be accepted on both Friday, July 24 from 4pm to 7pm and Saturday, July 25, 10am to 4pm, at the Photo Entry Desk in the Hobbies/Craft Building, Thurston County Fairgrounds. No prints will be accepted after 4:00pm on Saturday, July 25th.

3. It is necessary to enter the following in the upper left corner on the back of EACH PRINT mount. This information is essential:
 - Title of your print
 - Your full name
 - Your complete address
 - Your phone number
 - Lot and class
 - Entry Number (taken from [Fair Entry](#)). To find the Entry Number, select "View" from the main page where your entry/entries are listed. Then select "Detail" to see the Entry Number for each item.

RULES

1. The exhibitor of the picture must be the original maker of the image and all elements of it. Images that have been created, in whole or in part, using so-called artificial intelligence or "AI" software are not allowed in the Open Class Photography Exhibit. All images must originate as photographs made by the entrant. If the image is a composite, all of the elements of the image must originate as photographs made by the entrant. The use of third-party textures, skies, or stock photos is not allowed.

AI tools, such as Photoshop's Generative Fill, may be used to remove elements from an image but may not be used to add elements beyond what pixels are necessary to fill the removed area. The filled area should be consistent with the existing image. An example might be the removal of a person from the front of a rock. The software may be used to fill in rock details where the person was previously. The software may not be used to replace the person with an animal or some other element that wasn't there in the first place.

Prints will be accepted only as specified above. If, in the judgement of the superintendents(s) a print does not conform with these rules it will not be judged or displayed.

2. Prints entered MUST be identified with the information specified above.
3. Any print with words or logo that identify the maker will be disqualified.
4. All exhibits must be mounted and/or matted. If matted, the backs of the matted print should be completely covered. Foam core mounts and/ or matte board style is preferred. Framed prints, metal prints, and prints mounted with wood, glass or acrylic will not be accepted.
5. No hooks or wires are to be placed on the back of the print mounts.
6. A maximum of 8 prints will be accepted from each exhibitor. A maximum of 5 prints may be entered in any one Lot.
7. **The minimum entry size is 8" x 10"**, and the maximum entry size is 16" x 24." Entry sizes will be measured, including matte (if applicable). Odd sized entries are acceptable so long as the

shortest side is no longer than 16" and the longest side is no more than 24." Panorama images are an exception to this rule but may not exceed a 12" x 36" measurement. Square formatted images are limited to 18"x18."

8. An entry may contain multiple images on one mat or mount so long as dimensions are not exceeded. Multiple image entries will be judged as a single entry.
9. Hand colored black and white prints are acceptable in the Black and White category, so long as there is only one color in addition to black and white. Any entry with two or more additional colors will be considered a color print.
10. An exhibitor may not make multiple copies of an image and enter them into different lots.
11. Any print previously entered in the Thurston County Fair Open Class Photography may not again be entered.
12. Following acceptance of prints, the prints will be judged the following day, Sunday, July 26 at 10am. Exhibitors may attend the judging so long as exhibitors in no way interfere with the judging process. Judges are encouraged to talk about the images and give feedback to the audience as time allows.
13. Admission tickets to the Fair are not provided to exhibitors.
14. Ribbons will be awarded to winners. All ribbons will be hung with the print in the exhibit.
15. If you wish to retain packaging for picking up your prints, you must take it with you after delivering your prints as there is no means for storing or retrieving such items at the fairgrounds.
16. Exhibits must be picked up at the Photo Exhibit desk in the Hobbies/Crafts building, Thurston County Fairgrounds on Sunday August 2nd between 7pm - 8:30pm or on Monday August 3rd, between 4 - 7pm. Entries will not be mailed to exhibitors. Entries will not be returned to the frame shops. Following Monday August 3rd at 7pm, any remaining entries may be discarded.
17. All precautions possible will be taken with entries. Judging and hanging of prints requires extensive handling. Your prints will often end up with fingerprints from this or from visitors to the fair. The Fair or its volunteers are not responsible for lost, stolen, or damaged exhibits.
18. As this is an exhibit for all age groups consideration should be given as to the content of an image; the Superintendent reserves the right to disqualify and withhold from display any photograph they deem inappropriate for a family fair.

SECTIONS, CLASSES, LOTS

ADULT SECTION

CLASS 30070: Color Prints

LOTS:

03: Action: Implying motion: sports, moving cars, bikes, people, animals etc.

04: Domestic & Captive Animals: Zoo animals, livestock, pets, butterfly houses, etc.

05: Wild Animals: Wild animals in their natural habitat, amphibians to zooplankton, not including birds.

06: Wild Birds: Photographs where a bird or birds are the subject.

07: Nature Scenes: Landscapes, seascapes, night photography, etc. Minimal evidence of "man," meaning no significant elements contributed by people, buildings, bridges, etc.

08: Scenery with Man-made Object(s): Scenes that contain something man-made that is a significant element of the scene. Examples: building, pier, lighthouse, barn, boat, road, that is part of a larger scene.

09: Man Made Objects: Images of objects or structures themselves, where the background is incidental and the subject is the object(s) or structure(s).

10: Plants & Flowers: Plants and flowers in the wild or garden. Cut flowers or plants are allowable if the image is of only the plant.

11: Macro: Includes true macro and very close up images.

12: Still Life & Table Top: Static arrangements. Inanimate subject matter, including floral arrangements, food, etc.

13: Creative Imagery: Images heavily manipulated with a computer. The final result must be all the photographer's own work including the original images.

14: Abstract Images: No readily defined subject – patterns, textures, intentional camera movement, etc.

CLASS 30080: Monochrome Prints (black and white images)

01: People: People doing everyday things. Usually candid and unposed.

03: Action: Implying motion: sports, moving cars, bikes, people, animals etc.

04: Domestic & Captive Animals: Zoo animals, livestock, pets, butterfly houses, etc.

05: Wild Animals: Wild animals in their natural habitat, amphibians to zooplankton, not including birds.

06: Wild Birds: Photographs where a bird or birds are the subject.

07: Nature Scenes: Landscapes, seascapes, night photography, etc. There should be minimal evidence of "man" meaning no significant elements contributed by people, buildings, bridges, etc.

08: Scenery with Man-made Object(s): Scenes that contain something man-made that is a significant element of the scene. Examples: building, pier, lighthouse, barn, boat, road, that is part of a larger scene.

- 09: Man Made Objects:** Images of objects or structures themselves, where the background is incidental and the subject is the object(s) or structure(s).
- 10: Plants & Flowers:** Plants and flowers in the wild or garden. Cut flowers or plants are allowable if the image is of only the plant.
- 11: Macro:** Includes true macro and very close up images.
- 12: Still Life & Table Top:** Static arrangements. Inanimate subject matter, including floral arrangements, food, etc.
- 13: Creative Imagery:** Images heavily manipulated with a computer. The final result must be all the photographer's own work including the original images.
- 14: Abstract Images:** No readily defined subject – patterns, textures, intentional camera movement, etc.
- 15: Miscellaneous:** Images that don't fit in other lots.
- 16: Thurston County Fair Mascot:** Bald Eagle (Colonel Beaks) **Note:** Due to the popularity of eagles as subject matter, there will be a limit of one image per photographer in this lot.

YOUTH SECTION

CLASS 30090: Junior ONE CLASS ONLY - Color and Black & White will be judged together.

LOT:

CLASS 30091: Teen ONE CLASS ONLY - Color and Black & White will be judged together.

LOT:

- 17: People:** Includes candid, portrait, human interest.
- 18: Scenic:** Landscapes, waterscapes, etc.
- 19: Animals:** Birds, insects, animals, etc.
- 20: Plants & Flowers:** Flowers, plants, leaves, etc.
- 21: Miscellaneous:** Images that don't fit in other lots.
- 22: Thurston County Fair Mascot:** Bald Eagle (Colonel Beaks) **Note:** Due to the popularity of eagles as subject matter, there will be a limit of one image per photographer in this lot. If two are submitted, one must be color and the other monochrome.

Extended Lot Definitions:

In the adult section many images could fit into more than one lot. This section provides guidance on how to make the decision of which lot might be best. Note that lots with little chance of confusion are not included.

Extended descriptions, Group 1

Group 1 is composed of three lots:

People: People doing everyday things. Usually candid and unposed.

Portraits: Intentionally posed people, not candid in nature. Asking someone to "hold that pose" is adequate.

Action: Implying motion: sports, moving cars, bikes, people, animals, etc.

People, extended: People photographed in everyday settings, doing everyday activities. This can include almost anything from hanging laundry, playing a game, walking down the street or reading a book. The subject of the image is clearly the person or people in it, not the setting. Thus, it is unlikely that an image of a hiker or hikers small in the frame with Mount Rainier dominating the scene would do well in this lot. By the same token, the candid head shot of your child or significant other reading that book, even though they weren't aware of you taking the picture, might do better in Portraits, simply because it looks like one. The same person, photographed playing with your dog, or licking an ice-cream cone is more appropriate for People. The division between People and Action lies in the subject matter of the image. Is the subject a person or persons who happens to be in motion or is the subject the motion itself? Thus, freezing the motion probably fits better in People whereas a pan blur might be more appropriate for Action. A dancer whose head is still, but whose body or clothing is blurred by motion, might be a borderline case and becomes a judgement call by the photographer based on their intent.

Portraits, extended: Portraits are by definition posed. The pose can be unintentional, but if the photographer asks the subject to "hold that pose" it would probably be appropriate for this lot. As noted in the People discussion, some candid images could also fit in Portraits but would probably be limited to people in sedentary poses where it becomes very difficult to differentiate whether it's intentional or not. While studios and controlled lighting have been one of the hallmarks of portrait photography, natural light and relatively uncontrolled backgrounds do not prevent an image from fitting into Portraits.

Action, extended: This lot is not about the obvious subject of the image, be it human, horse or hound. It is about how well the image conveys the feeling of action or motion. Pan blurs where the subject is fairly sharp but the background is badly motion blurred are the classic example, but as noted under the People discussion, dancers or runners, antelope, cheetahs or whatever with parts of the body motion stopped and other parts or clothing motion blurred can be very effective. This was a new lot in 2024, and the best in lot was an off-road vehicle trailing a huge plume of sand. The area to be cautious is when photographing people or animals in action. Pure stop action doesn't usually convey motion well enough to do well in this category and those images are best placed in the lot corresponding to the subject of the image.

Extended descriptions, Group 2

Group 2 is composed of three lots:

Domestic and Captive Animals: Zoo animals, livestock, pets, butterfly houses, etc.

Wild Animals: Wild animals in their natural habitat, amphibians to zooplankton minus birds.

Wild Birds: Birds, free and wild. This excludes domestic birds, caged birds, or birds in an aviary.

Domestic and Captive Animals, extended: This lot covers pets, livestock, animals in zoos or aviaries, set up reptile photography classes, butterfly houses or any other situation in which the animal is restrained. Other examples include raptor rehabilitation demonstration flights, falconry, aquariums, wild animal parks, or game farms.

Wild Animals, extended: Animals that are free and will remain free so far as the photographer is aware. Temporarily restrained animals, such as might be encountered in capture and release should be under Domestic and Captive Animals. Wild birds have been moved to a separate lot because they were dominating this lot. As implied in the brief description, this can be any kind of animal as long as it's in the biological class of animals regardless of size. That said, very small animals and microscopic ones could also be placed in the Macro lot. That is up to the judgement of the photographer, but they would probably fare better in Macro, particularly since there tend to be less images in that lot and it does not have the restriction that they be "wild and free" or even alive.

Wild Birds, extended: Birds in their natural areas, free to come and go. Feeding stations and baiting are acceptable. Aviary or zoo photography, tame, captive, or domesticated birds are not allowed in this lot. While this lot does not specify a "limited hand of man", images showing birds in feeders or perched on man-made structures, etc. tend to fare less well in judging than those in more natural environs.

Extended Photo Category Descriptions, Group 3

Group 3 is composed of three lots:

Nature Scenics: Landscapes, seascapes, night photography, etc. There should be minimal evidence of "man" meaning no significant elements contributed by people, buildings, bridges, etc.

Scenery with Man-made Object(s): Scenes that contain something man-made that is a significant element of the scene. Examples: building, pier, lighthouse, barn, boat, road, that is part of a larger scene.

Man Made Objects: Images of objects or structures themselves, where the background is incidental and the subject is the object(s) or structure(s).

Nature Scenics, extended:

This lot celebrates the beauty and diversity of our natural world, encompassing a wide range of scales from grand vistas to intimate landscapes and small scenes. The focus should be on unmodified natural environments. The scene depicted should be as free as possible from the influences of human activity. As such the scene depicts natural landscapes which include but are not limited to forests, mountains, deserts, seascapes and the sky. The scene may also include agricultural and other rural landscapes. Historical structures or human elements that have been integrated into the landscape over time (fence lines, hedgerows, paths, old ruins) are acceptable but should not constitute the subject or a major element of the image.

Scenery With Man-made Object(s), extended:

This lot includes rural scenes in which a man-made object is a significant element. Examples include, a scene containing a barn or old house as a major element, an estate including both plantings and buildings, a rural scene in which a bridge or other man-made structure is a major element, etc.

Man Made Objects, extended:

This lot is for the objects or structures themselves. It could be a building façade, a bridge, a train, ship, car, cityscape, industrial building interior or exterior, the inside of a lighthouse, etc.

Extended Photo Category Descriptions, Group 4

Group 4 consists of two lots:

Plants & Flowers: Plants and flowers in the wild or garden. Cut flowers or plants are allowable if the image is of only the plant.

Macro: Includes true macro and very close up images.

Plants and flowers, extended: The primary subjects are plants and flowers in their natural setting. It can include plants in gardens or parking lots, potted plants, wildflowers, or shots taken with picked flowers, as long as the subject and focus are on the natural components of the plant (i.e., stems, petals, leaves). Cut flower arrangements, especially if they include vases, tabletops or backgrounds should go in Still Life and Tabletop.

Close up of fungus, algae, liverworts, moss, grasses, or parts of a plant or flower, depending on the photo might go better in Macro as this category usually has fewer entries. A plant picture showcasing a variety of plants, such as a garden photo, could go here or in landscapes.

Macro, extended: Shot with a macro lens or macro feature (on camera or phone without macro lens). Up close, not using a macro lens, but shows close up detail. Pictures taken with a microscope. Some pictures that might be in macro could also go in Abstract if it is difficult to distinguish what the subject is. They might also go well in other categories such as plants & flowers, etc. However, macro is a good choice as it tends to have fewer entries.

Extended Photo Category Descriptions, group 5

Group 5 is composed three lots:

Still Life & Table Top: Static arrangements. Inanimate subject matter, including floral arrangements, food, etc.

Creative Imagery: Images heavily manipulated with a computer. The final result must be all the photographer's own work including the original images.

Abstract Images: No readily defined subject – patterns, textures, intentional camera movement, etc.

Still Life and Table Top, extended – This lot covers staged arrangements of objects, usually on a small scale, but not limited to that. Usually, the lighting will be controlled by the photographer. While Still Life is in the title, that is not an absolute requirement as such things as water drop or smoke photography would likely be in this lot. Note that smoke photography, for example, might fall into abstract if it is photographed or processed so that it is not obvious that smoke is the subject. Note also that there is no requirement that it be photographed indoors. Dioramas with some natural elements and some man-made objects would still fall within this lot.

Creative, extended – This lot is designed for images that are heavily manipulated or composed in processing, though some cameras can create images using their processing capabilities that would qualify. Generally, applying a canned “look” to a portrait for example, might do better in the portrait category itself since it displays the creativity of the software developer more than the photographer. Combining multiple filters or multiple images to create a new image fits best in this lot.

Abstract, extended – As noted above, sometimes tabletop images can fit into the abstract category. The real test is if the average viewer goes “What the heck is that?” when they see it. Some abstract images are more representational than others, but they all depart from strict the “normal” view of reality. There can be a large overlap between this lot and the Creative lot because images can be processed to become abstract or can remain quite representational even though composed of multiple images or with distorting filters applied. There can also be an overlap with the Macro lot in this category, since taking a close-up image of patterns in sand or grain in wood and many similar things, when removed from context, can be considered abstracts even though they are very representational. Once again, show it to some friends to see if it passes the “What the heck is that?” test.

JUDGING PROCEDURE:

Prints will be judged on the following criteria:

- Impact of picture
- Composition and subject matter
- Technical merit
- Quality of presentation
- Adherence to the submission rules

Three judges will collaborate to judge each lot and award ribbons using a modified "Danish" system. They will be permitted to award as many of each ribbon as they feel is merited by the photographs in the lot. The judges will award a "Best of Lot" ribbon to the print selected as the best in each lot and they will award a "Best of Class" ribbon to one entry from each class. Finally, the judges will collaborate to choose one print as "Best of Show" for the Adult section and one "Best of Show" for the "Junior/Teen" sections. In addition, each judge will award a "Judge's Choice" ribbon to a print of their individual choosing. There will also be a "People's Choice" ribbon awarded for each day of the fair. Each print may earn only one "People's Choice" ribbon.

NOTE: Any lot with insufficient monochrome entries will be combined with Color entries for judging. Any single lot with less than five entries total will be judged with the Miscellaneous lot of the appropriate Class.

PREMIUM POINTS:

Premium points will be awarded for 1st, 2nd, and 3rd place winners only. Honorable Mention winners will be awarded a ribbon, but no points.

PREMIUM POINTS

BLUE (1st place) - 50

RED (2nd place) - 30

WHITE (3rd place) - 15

Best of Lot, Best of Class, Best of Show and Judge's Choice Awards will be ribbons only.

NOTE FROM THE SUPERINTENDENT: As the world of photography changes, we must update some of the rules that go along with this competition. Digital photography is now more prominent than film photography. We encourage everyone to do what they feel is necessary to correct colors, improve sharpness, and make their entries the best they can before the fair. However, if you are creating an image from multiple photos to create a whole new image, please remember to use Lot L for adults or T for Juniors so that your creativity can be judged on the same level as other images that are equally creative. We want to encourage everyone to feel their work is accepted and judged fairly at the Thurston County Fair.

PLEASE READ RULES AND CLASS/LOT INFORMATION CAREFULLY:

1. NO LATE ENTRIES ACCEPTED
2. Use the [Fair Entry](#) system to register your exhibit
3. Exhibit Description: Please use the [Fair Entry](#) description field for the title of your entry and additional information that will help judges and fair participants appreciate your work.
4. No items accepted that have been previously exhibited at the Thurston County Fair.
5. Textile items must be completed within the last two years. Canned & dehydrated foods and dry mixes must be prepared after August 1, 2025.
6. Entries must be made by the exhibitor. Any home arts entries determined by the judges to not be made by exhibitor will be disqualified and all other home arts entries entered by that exhibitor will also be disqualified and removed from show.
7. Textile exhibits that are not clean, pressed, odor free, and in good condition will not be accepted, or will be disqualified.
8. Please cover all names on all entries, such as quilt labels and personalized beverage labels, with painter's tape or other appropriate covering.
9. Some classes may require additional information included in the Exhibit Description such as cake variety or beer subtype.
10. Home Arts Department reserves the right to change the category in which an exhibit is entered.
11. For Textile Divisions and Food Divisions Baking, and Kitchen Arts, up to 3 entries may be entered per exhibitor per Lot
12. For Food Divisions Food Preservation and Beverages, up to 10 entries may be entered per exhibitor per class. However, only one exhibit of the same product may be entered per exhibitor per class.
 - a. Exhibits in question are referred to superintendents, whose decision is final.
 - b. Items processed differently are considered different entries, for example tomatoes processed in juice and tomatoes processed in water are different entries.
13. You may not enter the same exhibit in more than one division, class or lot. Exhibits entered in other fair divisions may not be entered in Open Class Home Arts.
 - a. 4-H participants are encouraged to enter exhibits into Open Class Home Arts, but may not enter the same exhibit in Open Class that they enter for 4-H.
14. The Thurston County Fair uses the Danish system of judging, whereby judges evaluate each exhibit against a set of standards or criteria. Judging standards are the same for Youth and Adult exhibitors. Ribbons are awarded as follows: "Excellent" exhibits receive Blue ribbons; "Good" exhibits receive Red ribbons, and "Fair" exhibits receive White ribbons. This system results in many Blue, Red, and White ribbons being awarded, since each exhibit receives a ribbon (unless it is disqualified during judging). A judge's decision is final.
15. Premium points and judging criteria are shown in each section. Points are awarded only to Blue and Red ribbon winners. Premium Points are totaled for each exhibitor to determine whether or how much premium money will be paid to them by the fair. The fair will not pay any premium if the award is less than \$5.00 per exhibitor. Please refer to the General Rules and Regulations of the Thurston County Fair for more about premiums
16. No one entering a division may judge their own entries. Please notify a superintendent as soon as possible if you will be judging and wish to enter in division or class you will be judging. Superintendents will make alternative judging arrangements for your exhibit(s).
17. The Fair will make every attempt to display all items entered; however, some articles may not be displayed or only be partially displayed. Exhibits that are disqualified are not displayed. Superintendents determine how items are displayed
18. Home Arts Department welcomes entries from all skill levels and ages.
19. Home Arts Department may award merit ribbons for Champion and Reserve Champion for a division, Best of Class, and others, depending on the quality of exhibits entered. No Premium Points are awarded for these merit ribbons.

20. Home Arts will take every precaution possible to protect all items. Thurston County Fair and its volunteers assume no responsibility for loss or damage.

Open Class Home Arts Master Maker Award

This special award will be given to a competitor demonstrating proficiency in a variety of skills. The Home Arts Master Maker award is a standalone honor, but a decision is dependent upon results for the exhibitor's individual entries within the Home Arts Department. Superintendents determine the recipient of the Homemaker Award. A \$50 prize is awarded to the Master Maker.

RULES:

1. You must indicate your intent to compete for the Home Arts Master Maker Award by registering your exhibit in [Fair Entry](#) for the award and telling the superintendent when you bring in both your textile and food items.
2. The Exhibitor must enter at least 6 of these 8 Divisions: Needle Arts, Quilting Arts, Sewing Arts, Fiber Arts, Baking Arts, Food Preservation, Beverages, and Kitchen Arts.
3. At least one blue ribbon must be awarded in each Division entered to qualify for the Home Arts Master Maker Award.
4. Winner will be decided by total points. In the event of a tie, the Superintendents will decide based on the complexity and workmanship of the articles entered.
5. A cash prize of \$50 will be awarded by the Home Arts Department.
6. The winner of this award must wait three years before competing for this award again.

Open Class Home Arts Quilt Block Contest

There is no entry registration required to participate in the Quilt Block Contest.

Thurston County Fair Open Class Home Arts Department sponsors a Quilt Block Contest every year. Out of all the entries submitted, a committee chooses the top twelve blocks to be used to create a special quilt that is raffled in a subsequent year to raise funds for the Home Arts Department. The funds are used for special prize ribbons and prizes such as the annual Home Arts Master Maker Award. Blocks not chosen for the raffle quilt are bundled in groups of 6 to 12 blocks and distributed to recipients who are randomly drawn from among participants in the contest.

Here's how to participate in the Quilt Block Contest:

- 1) **Get a fabric kit:** Quilt Block kits are available at A Needle in Hand: 110 College ST SE, Lacey WA. 98503. (920 390-0032)
- 2) **Make your quilt block:** The kit will contain fabrics you use to make your block(s); no embellishments or three-dimensional elements are allowed.
 - a) You must use a minimum of 3 fabrics from the kit for each block and must use only fabrics from the kit.
 - b) Please make one or more 12-1/2 inch square block(s). Blocks can be any technique (pieced, foundation pieced, English Paper Pieced, applique, hand or machine embroidered, etc.) or style (realistic, representational, improvisational, or abstract). The work may be done by hand or machine.

- 3) The minimum entry is one block; kits may make more than one block. Enter as many times as you wish.
- 4) Make sure your blocks are exactly 12-1/2 inches square unfinished. Blocks not meeting this criterion will be disqualified. Measure your blocks again before entering them!
- 5) Enter your block(s) (unquilted). Bring to Heritage Hall at the Thurston County Fairgrounds during Open Class Home Arts Textiles Entry times: MONDAY, JULY 20, FROM 1PM TO 7PM. Your block becomes the property of Thurston County Fair Home Arts Department to be used in a raffle quilt during the following year's fair and as prizes for contest entrants.
- 6) Blocks are judged for EXACT 12-1/2" size. Then the top 12 blocks will be selected by superintendents based on appearance, design, construction quality, and creativity in use of the challenge fabric.
- 7) Blocks will be displayed in Heritage Hall during the Fair. Remaining blocks will also be displayed and will be distributed after the fair to contest participants drawn randomly. Home Arts Department will contact you if your name is drawn for a prize.
- 8) Pick up your prizes (if applicable) on MONDAY, AUGUST 3 FROM 1PM TO 7PM

Open Class Home Arts - Quilting

Quilted items are pieces with padding (insulation or batting) enclosed between layers of fabric or fabric and a backing (without a middle layer) and are held together by thread that is tied or stitched.

There are numerous quilt-making techniques, including piecing by hand or machine, English paper piecing, foundation paper piecing, applique, whole cloth quilt, hand or machine embroidered, miniature quilts, or a mix of techniques.

Styles can range from traditional symmetrical quilts, traditional quilts interpreted in a modern style, abstract designs, asymmetric designs, modern minimalist quilts, or a blending of styles.

The Danish System of judging is used, in which each exhibit is judged using standard criteria. Ribbons are awarded based on the following: Exhibits achieving Blue ribbons meet or exceed safety standards and have excellent aesthetics. Exhibits receiving Red ribbons meet safety standards and have good aesthetics. Exhibits receiving White ribbons meet safety standards but are judged as fair with respect to aesthetics. Exhibits that are disqualified will receive a reason and not be placed on display. Division rules:

 - Brands accepted include Ball and Kerr. Exceptions may be granted by a superintendent on a case-by-case basis, and the superintendent’s decision is final.
 - Commercial retail (e.g., mayonnaise) jars, colored jars, and jars with nonstandard shapes (e.g. hexagonal or pot-bellied) are not allowed.
 8. Jars must be clean of any residue.
 9. Lids – New, standard two-piece canning lids (flat lid and band) must be used. Remove screw bands before entry except where noted.
 10. Jar sizes:
 - All jams, jellies, sauces, relishes, salsas, dehydrated/dried foods, and seafoods must be exhibited in half-pint or pint jars.
 - Dehydrated foods, seafood, domestic meats, poultry, and game meat may also be entered in quart jars.
 - Vinegars may be entered in pint or quart canning jars with flat lids and bands or in clear glass decorator bottles that are capped (not sealed). Exhibits do not need to be processed and may be opened for tasting.
 11. Honey must be entered in one-pound Queenline honey jars
 12. When required, labels must be affixed to the jar lid.
 13. Jar labels must include (as appropriate for your product):
 - Exhibitor Number
 - Name of product
 - Date processed or dried
 - Packing method (hot or cold; specify pretreatment if any)
 - Processing or drying method (e.g., boiling water or pressure processing; or air, oven, solar, or dehydrator drying)
 - Processing or drying time
 - For tomatoes - amount of citric acid or lemon juice added
 - Drying pre-treatment used

5. All poultry must pass a disease and parasite inspection upon arrival and during the Fair. Be sure to dust poultry before entering them. Poultry having lice or showing signs of sickness or are excessively dirty will be refused entry by the superintendent and/or vet.
6. Birds shown in a trio or pen cannot be shown as singles.
7. Cash premiums will be given in all classes, if two or more in class and lot, otherwise ribbons only.
8. All poultry will be judged by the American Poultry Association's Standard of Perfection.
9. All poultry entered must be purebred and entered according to the Standards of Perfection. No crossbreeds.
10. All poultry should be banded with numbered bands for identification. This number should be recorded on the entry blank.
11. Chickens entered in Open Class cannot be entered as a 4-H entry.
12. Poultry will be exhibited in cages provided by the fair. Entries are subject to space availability. Feed and shavings will be provided for all entries during the fair. Exhibitors may be limited on entries by the Superintendent depending on space available.
