

## 2020-2021 Parent/Student Device Use Agreement

In this agreement, the District means Yuma Elementary School District One. The “student” means the student attending YESD1 schools; the “parent” means the parent or legal guardian of the student enrolled in YESD1. The “property” is the device owned by YESD1:

#### Terms:

- Student will comply at all times with the Yuma Elementary School District One’s Digital Learning Device Handbook and the Parent/Student Device Use Agreement. Any failure to comply may terminate the student’s rights of possession effective immediately and the district may repossess the property.

#### Title:

- Legal title to the property is with the District and shall at all times remain in the District. The student’s right of possession and use is limited to and conditioned upon full and complete compliance with this Agreement.

#### Loss/Damage:

- If the property is damaged, lost and/or stolen, the student and parent are responsible for the cost of repair or replacement value on the date of loss. Loss or theft of the property must be reported to the District (school personnel) by the next school day after the occurrence. If the device is stolen from the student away from school grounds, a police report should be filed within 48 hours. Any manufacturer’s defects must also be reported immediately, and no later than the next school day after the problem is identified. Parents may also enroll in the **District’s Device Protection Plan** for \$30 to defray the costs of potential damage.

#### Repossession:

- If the student does not timely and fully comply with all terms of this Agreement, the district shall be entitled to declare the student and parent in default and take possession of the property wherever it may be.

#### Term of Agreement:

- The student’s right to use and possession is at the discretion of the District and/or parent/guardian.

#### Appropriation:

- The failure to return the property on time, and the continued use of it for non-school purposes without the District’s consent, may be considered unlawful appropriation of the District’s property.

## 2020-2021 Parent/Student Device Use Agreement



The following rules and regulations pertain to the use and care of the device issued by Yuma Elementary School District One:

It is the student's responsibility to:

1. carry the device safely and carefully
2. never leave the device unattended
3. never loan the device to other individuals
4. clean the device only with a soft cloth, such as one would use with eyeglasses
5. never spray anything on or near the device (like cleaners, hair spray, or air fresheners)
6. keep food, beverages and ALL liquids away from the device at all times in order to avoid damage to it
7. utilize the device for strictly educational purposes
8. never deface the device with any writing, markers, engraving or stickers
9. never change or remove any district-applied labels
10. understand that the device is subject to inspection at any time without notice
11. never install any personal software on the device

### Device Repair and Insurance Notice

In the event that a Yuma Elementary School District One issued device is damaged, lost, or stolen, the student and parent are responsible for the cost of repair or replacement. Damage is inclusive of, but not limited to: liquid spills, physical abuse, heat damage, cracked screens, or other forms of neglect.

Should loss or damage occur, the District will assess the situation and apply one of the following designations to it:

- **Damage or Loss:**
  - Replacement/repair fees will be charged
  - **Screen/Other Damage - \$100.00**
  - iPad Case - \$55.00
  - Power Cord - \$30.00
  - Power Adapter - \$30.00
  - Replacement Cost - \$400.00
- **Manufacturer Defect:**
  - Covered under warranty
  - No repair fee will be charged
- **Loss of Functionality:**
  - The District will attempt to repair the device
  - If successful, no repair fee will be charged

### Homeowner's Insurance Notice
