#### CALL TO ORDER. 1.

A special meeting of the Santa Clara Valley Water District (Valley Water) Environmental Creek Cleanup Committee (Committee) was held on April 18, 2022, in the Headquarters Building Boardroom at the Santa Clara Valley Water District, 5700 Almaden Expressway, San Jose, California.

#### 1.1 Roll Call.

Committee members in attendance were District 1 Director John L. Varela, District 2 Director Barbara F. Keegan, and District 3 Director Richard P. Santos, Chairperson presiding, constituting a quorum of the Committee.

Chairperson Santos declared time open for public comment on any item not on the agenda.

Mr. John Davis, a San Jose resident, expressed concern on the continued presence of trash and fallen trees and on the no specified flow reduction at Coyote Creek where he owns properties; inquired about progress and location of Stream Maintenance Program Phase II project permitted under the US Army Corps of Engineer (USACE); asked whether the City of San Jose (CSJ) has a permit similar to Valley Water in the mitigation of stream flow; and asked about a contact person in CSJ to answer his questions on the said mitigation permit.

### RECOMMENDATION:

Receive information on the proposed Water Resources Encampment Risk Assessment.

#### SUMMARY:

At the April 18, 2022 Environmental Creek Cleanup Committee meeting, the Committee was informed about staff's efforts to develop a risk assessment tool to aid in evaluating the impact of creekside encampments.

The proposed Water Resources Encampment Risk Assessment (Attachment 1) seeks to provide staff with a uniform method of assessing the impact of encampments based on risk factors including: the location of an encampment and its effect on stream flow conveyance and maintenance access; safety issues such as fire risk, presence of criminal activity, and public safety; environmental issues such as the presence of hazardous waste and harm to riparian trees or critical species; and adjacency to critical infrastructure.

The Water Resources Encampment Risk Assessment will inform Valley Water's decisions to perform encampment abatements based on the totality of the impact to Valley Water facilities. This tool will standardize these decisions and provide an enhanced level of transparency.

- > 51-100 Moderate: Encampments are monitored, cleanups continue.
- 1-50 Low: Encampments are monitored, cleanups continue.

Encampment Risk Assessment Team: Comprised of Valley Water staff representing Watershed Field Operations, Security, Legal and Risk Management.

#### SUMMARY:
