SUMMARY:

A. Collaboration with Partner Agencies Regarding the Purified Water Program

Valley Water held several meetings with partner agencies to provide updates on the project progress including sharing the proposed purified pipeline alignment from Palo Alto to the Los Gatos Recharge System complex. Meetings were held with the Cities of Campbell, Santa Clara and Sunnyvale, as well as Caltrans, NASA and Google, to discuss the proposed alignment and go over questions and concerns from the respective staff members. Valley Water received utility information from the cities, which will be considered as part of the preliminary design of the pipeline alignment and included in the request for proposal (RFP) package to be released later this year.

B. Public Private Partnership (P3) Procurement of the Purified Water Project

Staff and the project consultants continue to refine the project technical requirements and engage in conversations with impacted parties on refining project requirements.

Access to the Virtual Data Room was provided to the short-listed P3 Respondents in March 2022 so that the Respondents could familiarize themselves with the available data and highlight any supplemental data that would be beneficial for them once the RFP is released.

C. California Environmental Quality Act (CEQA) Efforts Related to the Purified Water Project

The Draft Environmental Impact Report (EIR) for the Purified Water Project continues to be

developed to fulfill Valley Water's responsible agency duties under CEQA.

D. Outreach Regarding the Purified Water

Outreach staff continues conducting private and public virtual tours of the Silicon Valley Advanced Water Purification Center to inform the public on water reuse and the technologies to produce purified water. During March and April, the team hosted 16 private tours and 3 public tours. Some notable presentations and tours included the Valley Water Youth Commission on March 23rd, and the Interfaith Peninsula Climate Action group, a cohort of faith-based leaders from Peninsula cities, on April 6th; and Secretary of California Natural Resources Agency, Wade Crowfoot on April 14th.

In continuing to raise awareness and support for the Purified Water Project, staff continues reaching out to organizations primarily in San Jose, Palo Alto, and cities along the project pipeline route. Staff is developing new partnerships with the City of Mountain View Public Library and Los Altos Community Center to co-host public virtual tours for residents. Staff is working to procure consultant services to help strategize key stakeholder outreach for the Purified Water Project.

The conservation and purified water paid advertising campaign continues with countywide ads on various media including radio, online, and television. Staff recently worked on a video segment highlighting the Silicon Valley Advanced Water Purification Center and agency water reuse efforts, with interviews featuring Valley Water Chair Pro Tem John L. Varela, Chief Executive Officer Rick Callender, project staff and Dr. Steve Jackson, community public health advocate. The segment will air locally and nationwide.

SUBJECT:

Update on Direct Potable Reuse Efforts.

RECOMMENDATION:

Receive information on Direct Potable Reuse (DPR) regulatory developments and Valley Water engagement.

SUMMARY:

On March 22, 2021, the State Water Resources Control Board's (State Water Board) Division of Drinking Water (DDW) released the Addendum to the DPR Framework, 2nd Edition. This Addendum contained draft language of the criteria for DPR and was an important step towards developing uniform water recycling criteria on or before Dec. 2023 (per AB 574). Since then, four (4) Expert Panel meetings have been held publicly (Aug. 2021 - Feb. 2022). During these meetings the Expert Panel provided their feedback and recommendations on the proposed regulations to DDW. DDW will take into consideration the comments and feedback received from various agencies, stakeholders, and the Expert Panel in preparing the final DPR regulatory package aiming for submittal to the State Water Board by the end of 2022. These activities will pave the way for final administrative review and approval processes required for promulgation of the regulations. At this juncture it is expected that approval would be completed by the end of 2023.

As the owner and operator of the Silicon Valley Advanced Water Purification Center (SVAWPC) - the largest purification facility in Northern California - and with large scale potable reuse projects planned under the Countywide Water Reuse Plan (CoRe) throughout Santa Clara County, Valley Water is very active in the recycled water and potable reuse arena. Valley Water staff have been continually monitoring DPR regulatory developments and are engaged in the process through active involvement in related research, technical panels, and submitting comments on the proposed regulations. In particular, staff have participated in several important research and special studies conducted by the Water Research Foundation (WRF) with the focus on informing the DPR regulations. These special studies include enhanced source control programs and blending of purified and raw water.

Staff also collaborate with other utilities, academia, and research entities in joint technical studies, research projects, and treatment process evaluations to collect, analyze, and exchange various data

on water quality and operational parameters from SVAWPC to inform DPR related investigative studies.

Staff have been attending the public hearings on the released Addendum on DPR held by the State Water Board and will continue to monitor the regulatory developments.

SUBJECT:

Update on Valley Water Desalination Efforts in Santa Clara County.

RECOMMENDATION:

Receive information on desalination efforts as a water supply in the Santa Clara County.

SUMMARY:

Since 2003, Valley Water has been exploring potential desalination projects to help meet future water supply needs. One effort Valley Water is participating in is a collaboration with Contra Costa Water District, Zone 7 Water District, and San Francisco Public Utilities Commission to evaluate a Bay Area Regional Desalination Project (BARDP). BARDP is part of a broader Bay Area region water supply reliability coordination effort called the Bay Area Regional Reliability Partnership, which includes East Bay Municipal Utility District in addition to the BARDP partners.

Valley Water plans to continue evaluating desalination projects through its Water Supply Master Plan and its Monitoring and Assessment Program (MAP). Valley Water developed a scope of work for a preliminary feasibility study of Bay water desalination in Santa Clara County and is currently working with our consultant to begin this work. In addition, Valley Water also continues to participate in the BARDP, which is currently evaluating water rights constraints and the ability of the Los Vaqueros Reservoir (located in Contra Costa County) to help mitigate some of the water rights issues. Staff will continue to provide updates on regional and local desalination studies to the Recycled Water Committee when new information is available. Valley Water staff will also monitor recent legislation related to feasibility of desalination in the Bay Area.

SUBJECT:

Discuss the Evaluation of Alternative Purification Technologies.

RECOMMENDATION:

Discuss alternative purification technologies and make recommendations as necessary.

SUMMARY:

Valley Water acknowledges Dr. Steven White's comments made at the April 12th, 2022 Board meeting. The Board referred Dr. White's comments pertaining to advanced water technologies such as Structure Nanoparticle Adsorbent, Acoustic Nanotube, Photocatalytic Water Purification, Aquaporin Membrane, and Automatic Variable Filtration to this Committee.

Valley Water staff keep abreast of the latest purification technologies and are familiar with the latest water purification processes and techniques. While the technologies mentioned in Dr. White's comments are science-based and hold promise, they are only effective for specific applications and at small-scale. For example, Photocatalytic techniques for water purification are successfully deployed in pharmaceutical processes. However, these treatment systems have not been approved by regulators for water reuse projects and are not available for large-scale deployment. Staff is not aware of any agencies that use these treatment systems for water purification projects.

The technologies currently deployed for water purification such as Microfiltration/Reverse Osmosis (MF/RO) and UV advanced oxidation process (UV/AOP) used at the Silicon Valley Advanced Water Purification Center have been in service around the world and in United States for many years and are approved treatment technology under current regulations.

Valley Water staff continually explores new water purification technologies and participates in research and special studies. Valley Water is one of the leading agencies when it comes to collaborative efforts with Water Research Foundation, other reputable professional organizations, and universities. These joint efforts investigate many advanced water treatment technologies. Staff also actively participates in technical forums and national conferences, publish papers, and are involved in regulatory development processes.

The technologies stated by Dr. Steven White or other similar technologies have been evaluated and will continue to be monitored as staff keeps informed of technological advances in these arenas.

Work Plans are dynamic documents managed by Committee Chairs and are subject to change.

At the February 1, 2022 meeting, the Committee approved the 2022 work plan that has agenda items necessary for the continuation of the recycled water projects. Staff solicits Committee feedback on any additional timeline information for holding discussions on the assigned Work Plan items, and confirmation of the next meeting date on June 22, 2022.

An updated 2022 work plan (Attachment 1) proposes changes for the remaining meetings in the year.
