- Park or Recreation Facility**
(Please see Appendix C for description)
 - Community Center:**
Opportunity for the Community and County to collaborate on having a park, daycare operation, library, fire station, or other public facility at or next to Riley Hill Family Life Center. Possible public/private partnership.
 - Neighborhood Activity Center:**
 - Community Activity Center:**
Mixed use: Projected to permit one or more of the following: commercial, office, and institutional, multi-family (outside the water-supply watershed) or single-family homes, pedestrian paths, and bus or other transit stop(s).
 - Watershed Critical Area**
Residential use - cluster and other subdivisions-up to 1/2 dwelling per acre.
(minimum lot size of about 80,000 sq. ft. for a conventional subdivision).
 - Watershed Non-critical Area:**
Residential use - cluster and other subdivisions-up to one dwelling per acre.
(minimum lot size of about 40,000 sq. ft. for a conventional subdivision).
 - Rolesville Urban Service Area:**
Residential use - cluster and other subdivisions-up to two dwellings per acre. When municipal water and sewer become available.
(minimum lot size of about 20,000 sq. ft. for a conventional subdivision).
 - Wake Forest Urban Service Area:**
Residential use - cluster and other subdivisions-up to three dwellings per acre. When municipal water and sewer become available.
(minimum lot size of about 12,000 sq. ft. for a conventional subdivision).
 - Industrial/Major Employment Area**
Land suitable for manufacturing, warehousing, industrial and business uses, research and development, and supporting commercial and residential uses, in a manner appropriate for its location relative to other development and environmental constraints.
 - Proposed Little River Reservoir**
 - Not in Area Land Use Plan**
 - AO Airport Overlay District**
 - Little River Reservoir Greenway**
 - Town Greenway**
 - Historic Site**
