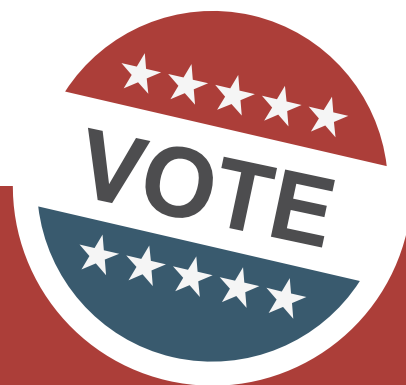

## Voter Registration

As of April 11, 2022 there were 798,537 Wake County Registered voters. Those voters registered with the Democratic and Republican parties do have a primary, however, the Libertarian party does not have a primary this year. The Town of Cary is also having their non-partisan municipal election at the same time as the primary.

## Rules Regarding Media Interviews and Photography/Video

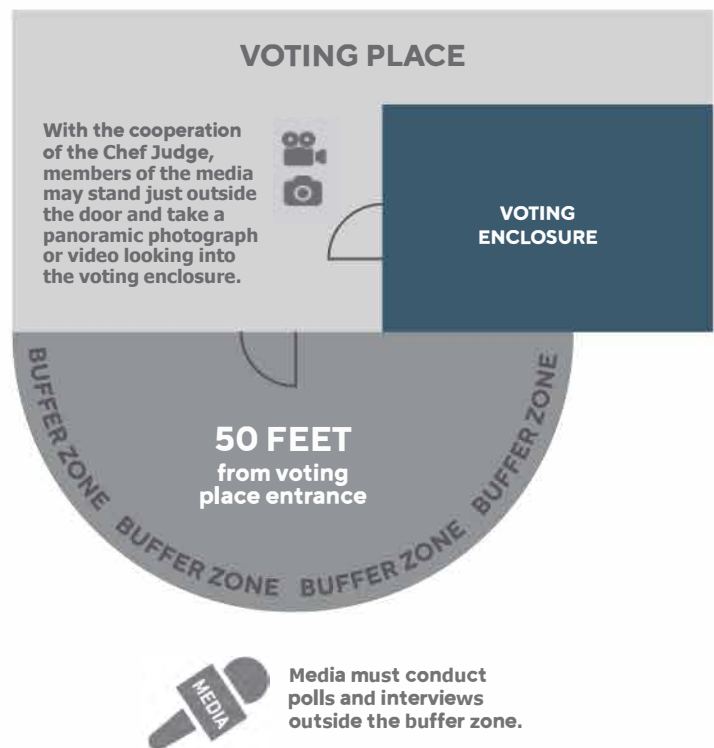
North Carolina General Statute 163-166.4 limits activity within the electioneering buffer zone that may “hinder access, harass others...” These 50-foot buffer zones are marked at polling places and Early Voting locations, are clearly noticeable, and apply to members of the public and the media.

Also, North Carolina General Statute 163-166.3 limits media access in the voting enclosure as follows:

(b) Photographing Voters Prohibited. - No person shall photograph, videotape, or otherwise record the image of any voter within the voting enclosure, except with the permission of both the voter and the Chief Judge of the precinct. If the voter is a candidate, only the permission of the voter is required. This subsection shall also apply to one-stop sites under G.S. 163-227.2, 163-227.5, and 163-227.6. This subsection does not apply to cameras used as a regular part of the security of the facility that is a voting place or Early Voting site.

(c) Photographing Voted Ballot Prohibited. - No person shall photograph, videotape, or otherwise record the image of a voted official ballot for any purpose not otherwise permitted under law.

- Members of the media must conduct media polls and interviews outside the buffer zone.
- Members of the media must identify themselves to the Chief Judge when entering the buffer zone.
- Photographing voters is restricted. No person (including media, other voters or parents) shall photograph, videotape or otherwise record the image of any voter within the voting enclosure.
- With the cooperation of the Chief Judge, members of the media may stand just outside the door and take a panoramic photograph or video looking into the voting enclosure but are not permitted to use a zoom lens that could show the individual voter in the process of voting.
- Members of the media should be positioned so that they will not obstruct or disrupt the voting process.
- After the polls close and all voters have left the enclosure, the media and public are allowed inside the enclosure but may not hinder the operations of the Precinct Officials.



## What is the major difference between Early Voting and Election Day?

During Early Voting:	On Election Day:
You could go to any Early Voting site.	You should vote at your home precinct, which is based on your address.
You can register and vote if you missed the April 22 voter registration deadline.	You must be a registered voter as of the April 22 deadline for your vote to count.

## What is the timeline for Election Night Unofficial Votes?

- Typically, after the polls close at 7:30 p.m., you will see the first unofficial results posted online before 8 p.m. These returns are the results for Absentee By Mail and Early Voting.
- After the polls close at 7:30 p.m., any voter in line at 7:30 p.m. will be allowed to vote. Precinct Officials will then begin auditing and inventorying all items as they close the polling place. Tabulators are then brought to the Board of Elections. This entire process can take 2-4 hours. Anyone wishing to see a precinct's results immediately after the close of polls may visit the polling place and view a results tape printed from the voting machine and posted on the wall for public viewing.
- It is anticipated that the first returns from the Election Day precincts should be posted at approximately 10:00 p.m. Depending on the length of a line at 7:30 p.m. and distance from the Board of Elections, it may take an hour or more after 10:00 p.m. for all tabulators to be returned and for the unofficial results to be posted.

## What is the timeline for Certification of Official Results?

- Results are unofficial until County Canvass which is 10 days after the election on May 27.
- Canvass is the official tally of votes for any given election.
- This accounts for every ballot cast and to ensure that every valid vote is included in the election totals.
- NC State Board of Elections will Canvass approximately three weeks after the statewide primary.

# Know Before You Go

Information the Board of Elections would like voters to know before going to the polls

## Voter Registration Deadline

VERY IMPORTANT

The deadline to register or update your address is April 22.

Early Voting is the easiest and best way to update your address or register to vote after the deadline.

## Election Day


Election Day is May 17. The polls are open from 6:30 a.m. to 7:30 p.m.

Voter lines are longest early in the morning and near the close of polls.

## Absentee Voting

- Deadline to request an absentee ballot is May 10 at 5:00 p.m.
- Deadline to return a voted absentee ballot is May 17 at 5:00 p.m. at the Board of Elections Office\*  
\*Mailed ballots must be postmarked on or before May 17.

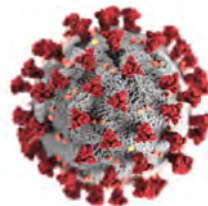
## Early Voting

- Historically the last two days of Early Voting are the busiest. Avoid the rush and vote during the initial days of the Early Voting period.

# FACTS ABOUT ELECTION SECURITY IN NORTH CAROLINA



## 1. NO EVIDENCE OF SUCCESSFUL ATTACK



North Carolina elections officials have no evidence that any election system or voting system in the state has ever been the target of a successful cyber attack.

## 2. PARTNERSHIPS



Elections officials are in regular contact and have strong and growing relationships with partners in federal and state governments, who assist with cyber and physical security, share information, plan for election events and respond to incidents.

## 3. PAPER BALLOTS



Under state law, all voting systems used in North Carolina must use paper ballots, producing a paper trail that can be audited. In 2020, all 100 counties will use paper ballots. By federal law, ballot marking devices must be available at every polling place for any voter who needs or wishes to use one to mark a ballot.

## 4. CERTIFIED VOTING SYSTEMS



All voting machines used in North Carolina are certified by the U.S. Election Assistance Commission after testing by certified laboratories. They are also certified by the State Board of Elections after additional testing, and all systems certified in North Carolina are certified, used and audited in other states.

## 5. NO INTERNET



By state law, voting machines may not be connected to the internet, limiting the possibility of cyber interference.

## 6. LOGIC & ACCURACY TESTING



Before every election, county boards of elections conduct logic and accuracy tests on every machine that will be used to ensure proper coding of ballots and counting of votes for every contest on the ballot.

## 7. BIPARTISAN, TRAINED OFFICIALS



Every polling place is staffed with bipartisan, trained officials from the local community who take an oath to uphold state elections laws and work together to ensure election security. Bipartisan State and County Boards of Elections oversee all aspects of elections.

## 8. AUDITS



After every election and before results are certified, the State and County Boards of Elections conduct audits designed to detect irregularities, such as equipment tampering, ballot stuffing and voting machine or tabulation errors.

## 9. INVESTIGATIONS DIVISION



North Carolina is one of few states with dedicated Investigations Division, which investigates reports of fraud and other irregularities and refers cases to prosecutors when warranted by evidence.

## 10. INFORMED VOTERS




Every voter can help promote election security by voting, checking their ballot before casting it, reporting problems with the voting process to poll workers and volunteering to work in elections. Also, voters should get information on elections from trusted sources, particularly elections officials, and verify information about elections before sharing it on social media.

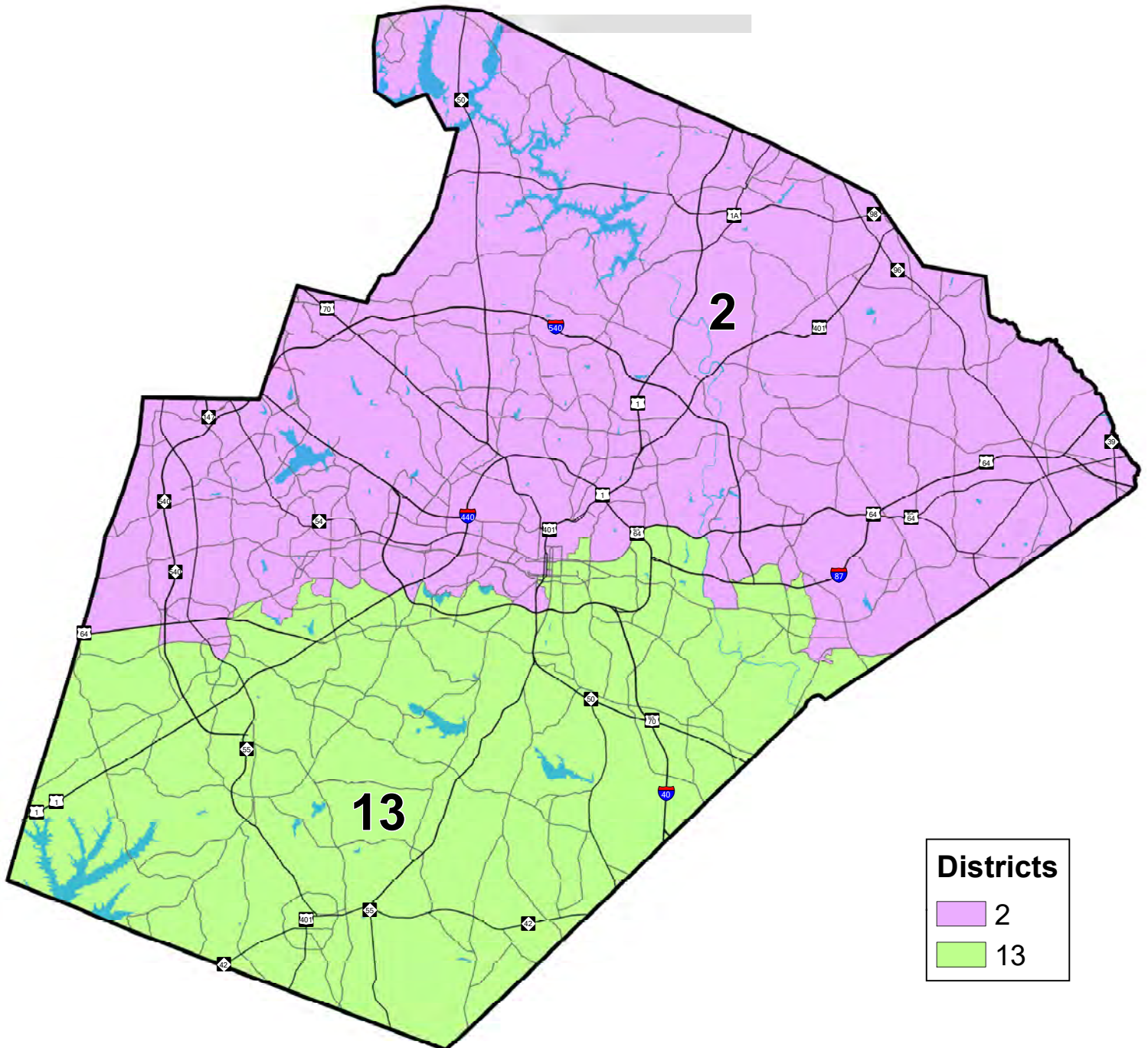

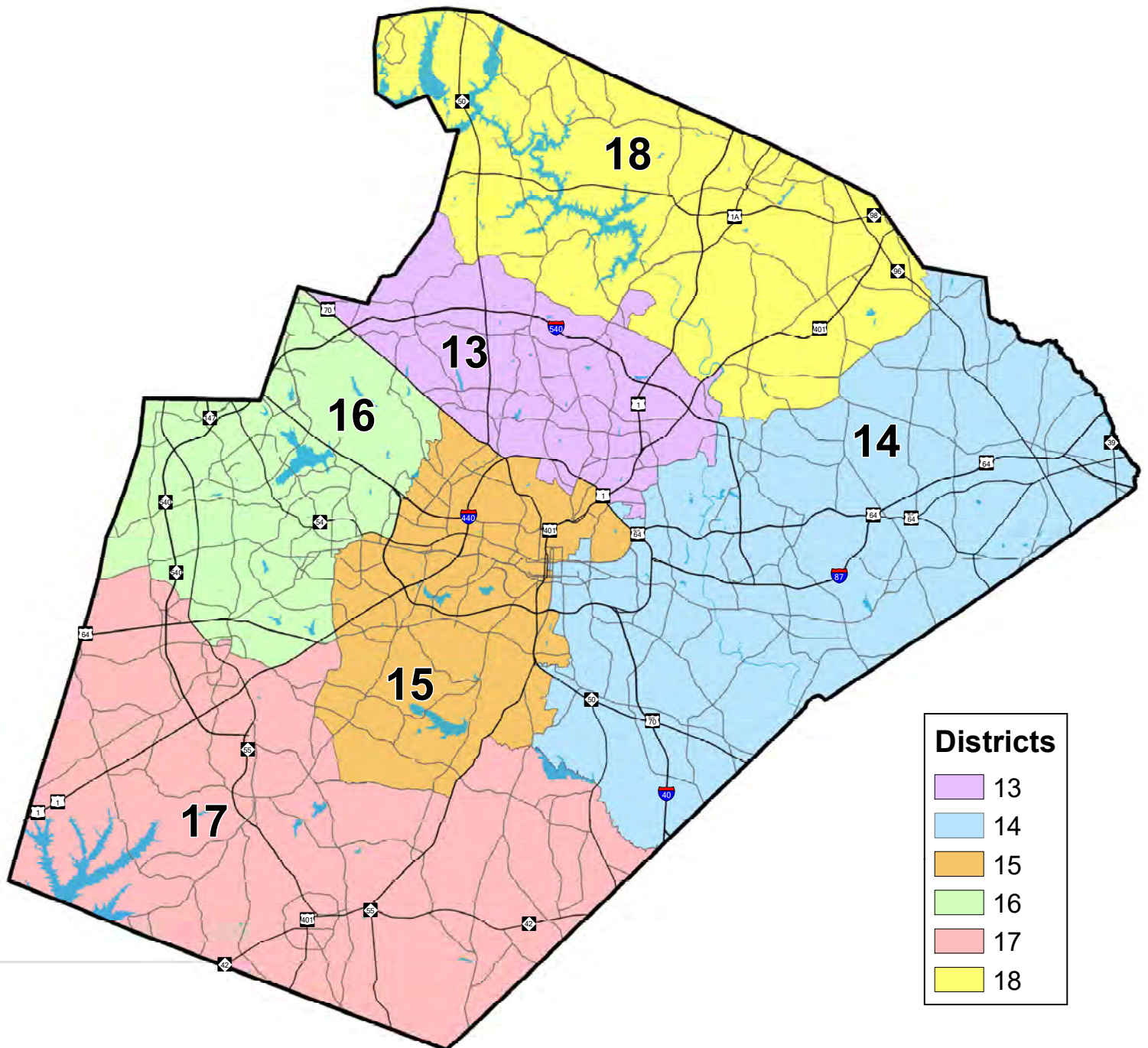

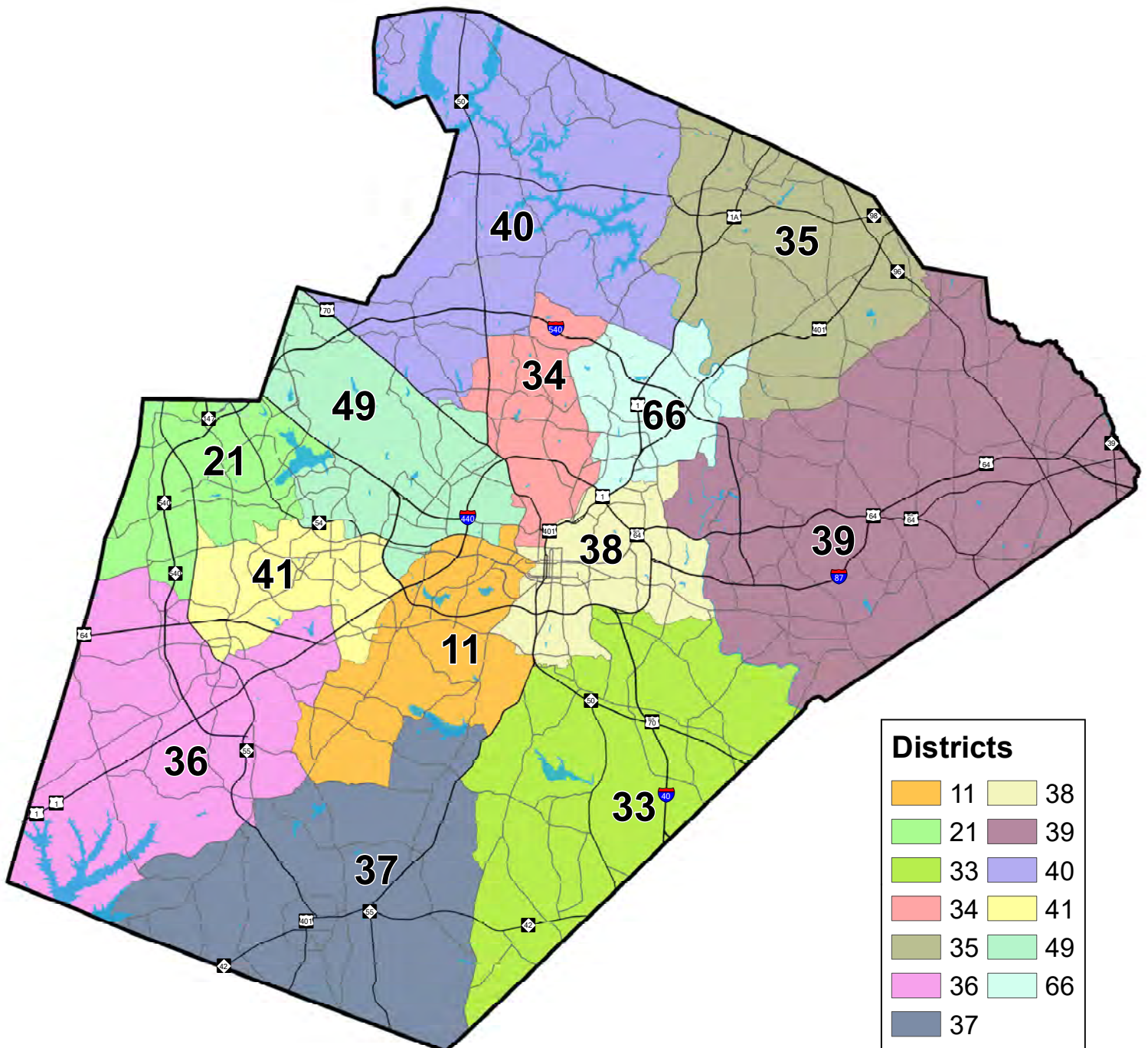

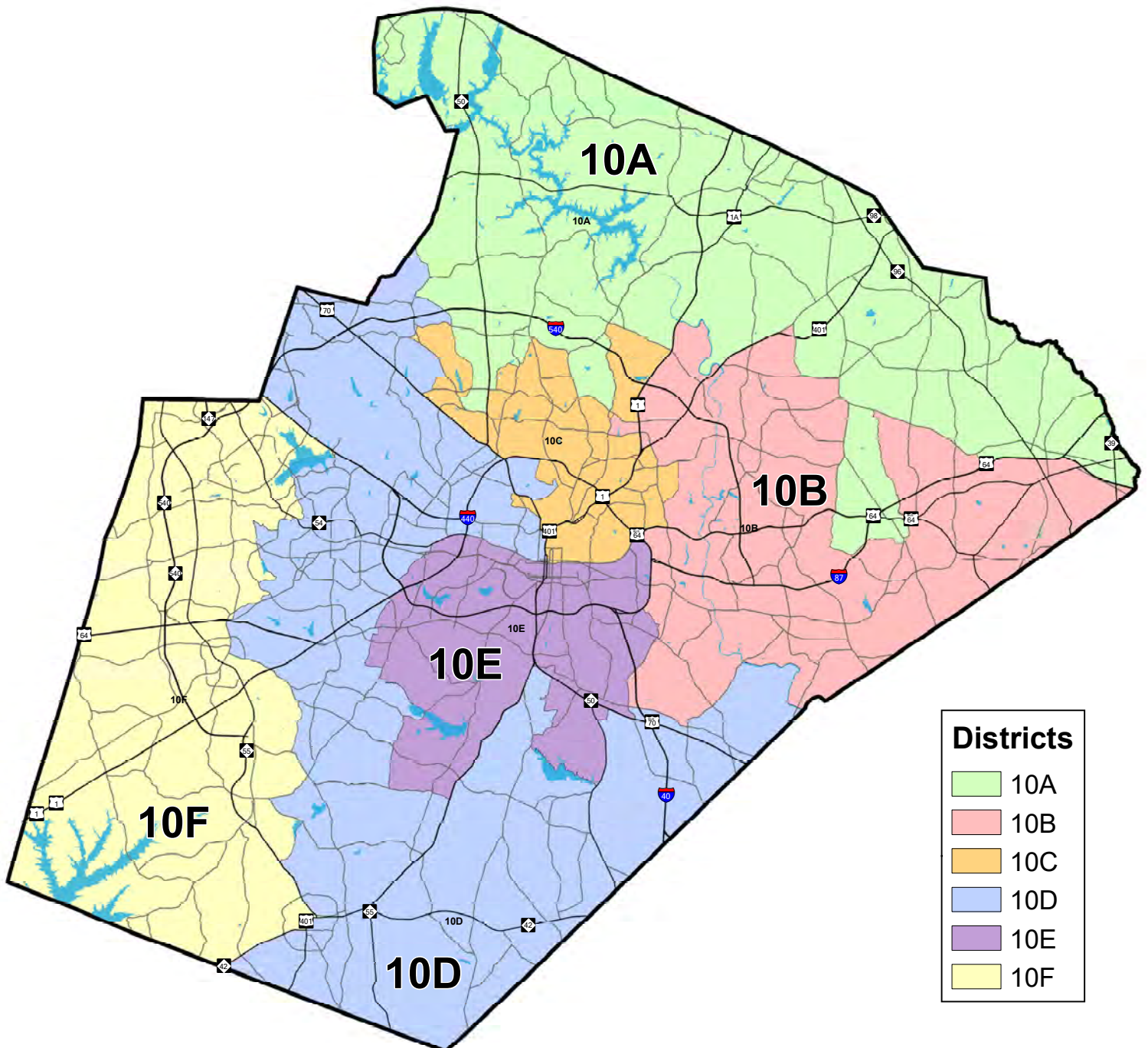

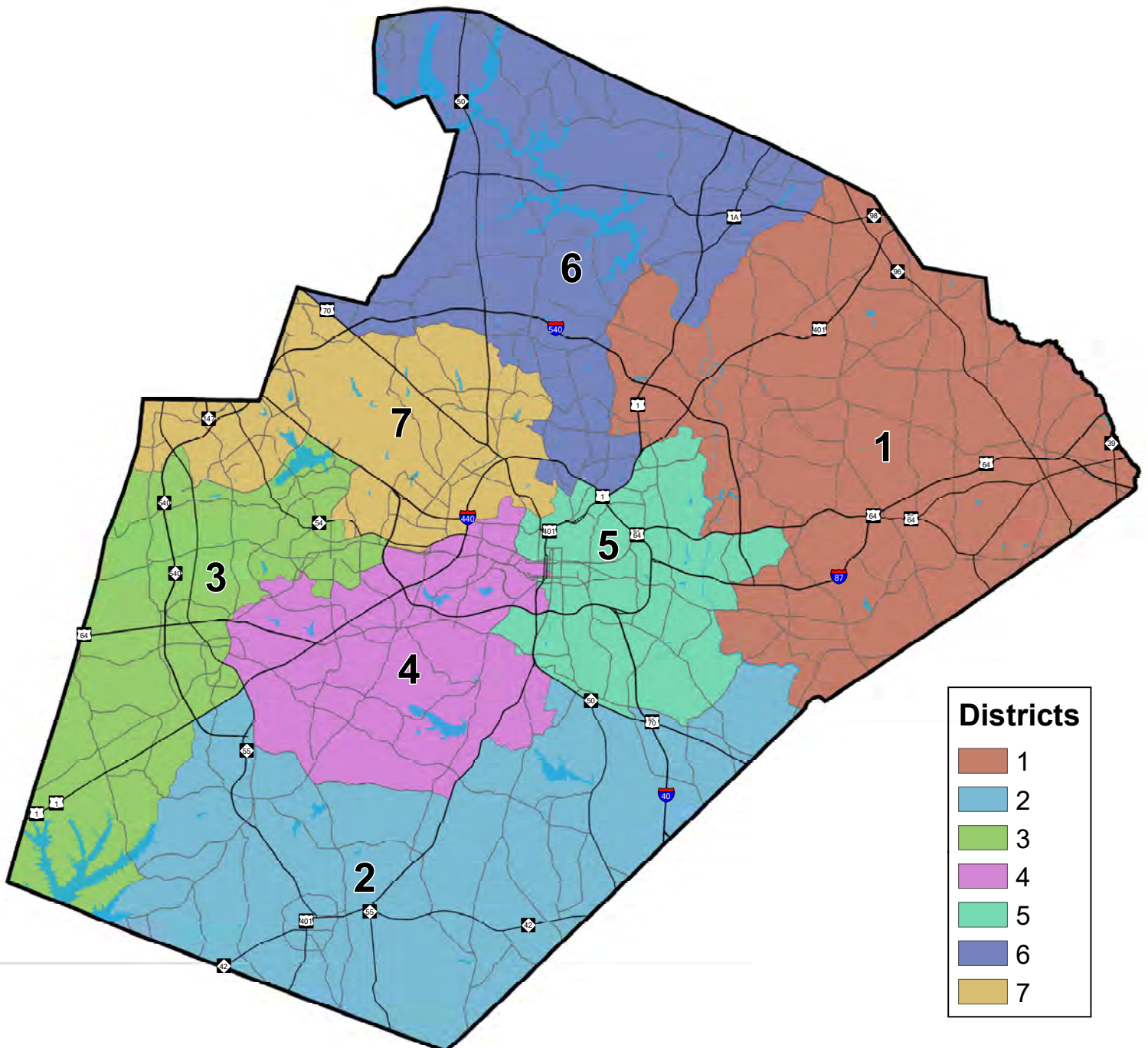
